CHAPTER IV.

IRISH LAND ACTS OF 1870 AND 1881.

The Land Law of Ireland required Amendment when the Bill of 1870 was brought forward--The Law then in Force had worked Bally--A Bill to Amend it brought into the House of Lords by Lord Clanricarde in 1867 referred to Select Committee, Amended, and recommended to the House--This Bill, with a Supplemental one, would have Redressed the Real Grievances of Irish Tenants--Bill proposed by Mr. Gladstone on an Opposite Principle--Contrast between the Two Measures--Injustice inflicted on Land-owners by the Last--Measure Defended by Mr. Gladstone on the ground of the "Hunger for Land" of the Irish People--The "Hunger" Real, but caused by Insufficiency of Available Land--Possible Remedies--The Act of 1870 had an Opposite Tendency--Principle of the Act unsound, and its Practical Operation more Injurious owing to Circumstances of Ireland--Improvement of Agriculture its most pressing Want

done!—The Present Ministers seem instead disposed to follow the Example of Mr. Gladstone—The Land Act of 1887 another step in the same direction as the Acts of 1870 and 1881—Bad Results of former Land Acts a reason against further Legislation on the same Principles; not the Conclusion generally come to—Disposition to accept wild Schemes—One much in favour to enable Tenants to buy the Land they hold—Objections to the Money difficulty—Impolicy of getting rid of Landlords; probable effect on the state of Society of their Removal—Evils from the present relations of Owners and Occupiers of Land produced by unwise Legislation and inefficient Administration during many years; to cure them must be a work of time—Difficulty to be expected in refusing fresh Concessions and enforcing Payment of Rents—Pressure will be brought to bear on Ministers—Importance of resisting it, and Reasons for doing so—By degrees a better state of things may be arrived at if there is no further unsound Legislation, and Order and Security are established—How Emigration may be useful—Some Opponents of Mr. Parnell's Scheme in favour of giving increased Powers of Local Self-Government to Irish people—These Powers they already have—Reasons against going further and creating either a single Council for all Ireland or one for each Province—Only one of the Powers Parliament exercises with regard to Ireland which it could with advantage—What is called the "Private Business" of Parliament relating to Ireland, ought to be done in Dublin rather than at Westminster—"Private" Legislation, both for Ireland and Great Britain, now conducted very ill—Reasons why a Reform is wanted, and Sketch of a mode of Effecting it—The Creation of any New Representative Body in Ireland would be useless for this purpose, and objectionable—The Manner in which Ireland has been Governed not to be approved—It has suffered much from Party Spirit in this Country—Evil much aggravated of late—Ireland has been Demoralized by what has happened, and its state now Deplorable—Two things necessary for a Change for the Better; firm Enforcement of the Law, and some arrangement

to secure wiser Legislation—First, the most Important ; General Poverty of the Population at the bottom of Irish Discontent

1—Poverty owing to want of security—This security Ireland has never enjoyed—Lawlessness has more or less prevailed from the absence of proper firmness and energy in the Executive Government—Errors and Omissions in Legislation have contributed to impede Improvement—In the present state of the House of Commons, little hope that either of the requisites for the Better Government of the Country can be obtained—Grave question thus forced upon us: Can Ireland be rescued from the Evils it is suffering from without suspending there for a time the Operation of Representative Government? No such Proposal would at present be listened to; but the requisites for the Improvement of Ireland are now unattainable—Great Britain is also Suffering—These Evils are becoming Unbearable; the Country may soon have to choose between Surrender to the Home Rule Party and Depriving it of the Power it Abuses—The First not to be thought of—If the Nation should be convinced of the necessity of a Complete Change in the System of the Irish Government, there would be no difficulty in effecting it—Sketch of a Plan for this—Better Modes of accomplishing the object are, no doubt, to be found, but the object one it is necessary to attain—Some Measure not less strong than that described indispensable page 146
