### INTRODUCTION.

In the Autumn of 1858, several Packets of old Deeds, relating to the Property of the Almshouse at Ilchester, were restored by the Representative of the late Lord Huntingtower, (formerly Sir William Manners) to the custody of the newly constituted Board of Trustees of the Ilchester Almshouse Charity. \*

These Manuscripts follow in regular succession, from the time of King John and Henry III., through the reigns of Edw. I, Edw. II, and Edw. III, Richard the Second, Henry IV, Henry V. and Henry VI, Edward IV, Hen. VII, Hen. VIII, Queen Elizabeth and James the First.

In some of them, the Regnal Date is wanting; and these undated Deeds are, most of them, anterior to the reign of Edward the First. One may probably be assigned to the time of King John, or to a period certainly not later than the commencement of Henry the Third's reign. The earliest recorded date is the seventh year of Edward I. Feb. 3rd, 1279.

They are written for the most part, in the usual contracted Latin; and some of the oldest of the manuscripts are very fine specimens of Calligraphy. A few, of the time of the Third Edward, are in Norman Freuch; and two or three, belonging to the latter part of the 15th and the beginning of the 16th centuries, are in the quaint old English of the Period.

From the Reign of Henry VIII, the Deeds are few in number, of less comparative interest, and chiefly in the vernacular tongue.

The Documents thus unexpectedly brought to light, by their restoration to the right owners, refer to Lands and Tenements situate in the Parishes of Stocklinch Magdalen, Stocklinch Ottersay, Montacute, Chilthorne Domer, the Manor of Sock Dennis, Ilchester, Northover, Limington, Somerton Erleigh and the Parish of Somerton; and a large proportion of the lands therein dealt with, including the Manor of Stocklinch, constitutes the Property of the Ilchester Almshonse Charity at the present time.

The most important of these Manuscripts, in relation to the Charity, are the two which bear date, respectively, on March 12, 1426, in the fourth year of Henry VI, and on Feb. 12, 1477, in the sixteenth year of Edward IV.

The former is the DEED OF FOUNDATION, executed by ROBERT VEEL; wherein he provides, that subsequently to the fulfilment of certain specified obligations, the Trusteeship of the Almshouse, and of the Charity Lands, should be vested in the Baillifs and Burgesses of Heliester and their Successors, for ever. The other Deed, is the Indenture made by Swanne, a Canon of Wells, and others, to the Baillifs and Burgesses; by which the intention and will of the Founder in this respect, were fully carried out.

These Transcripts are arranged in Chronological oderr; the contractions of the original text are for the most part omitted, and the abbreviated syllables are given in extenso. After each Transcript, is added an abstract of its contents, in English. The Appendix contains some brief notices of Mediaval Richester, arranged under separate heads, and elucidated by a Pian of the Town, on the basis of Dr. Stukelev's Ischaus.

### Ilchester Almshouse Deeds.

No. I. undated-Time of King John.

Sciant presentes et futuri quod ego Willielmus Dacus dedi et concessi et hac presenti carta confirmavi Herwardo pro homagio et servicio suo Mesuagium quod Paganus Hoperius tennit cum duabus dimidiis acris quas predictus P (aganus) tennit Et cum la Rig acra Et cum duobus sextariis prati que jacent juxta pratum H de Spegeton Quorum unum jacet versus Orientem et aliud versus Occidentem juxta predictum pratum H de Spegeton Et cum una perticata prati que jacet versus Occidentem juxta Kinges furlang Habendom et Tenendum sibi et heredibus suis de me et heredibus meis libere et quiete plenarie et integre Reddendo inde annuatim Undecim Solidos per quatuor anni Terminos Scilicet ad Festum Sancti Johannis tres et triginta denarios ad Festum S'c'i Michaelis xxxiii denar. William Dacus, (Dacres?) grants to Herward, for his homage and service, a Messuage held before by Hoper the Countryman; Also two half-acres held by the same countryman; and the Ridge acre, and two sixth parts (of an acre) of Meadow adjoining land of H. de Spegeton; and one quarter of an acre of meadow, eastward near Kinges furlang To Have and to Hold in consideration of a yearly rent of twelve shillings, to be paid quarterly, at the Feasts of St. John and St. Michael, at Christmas and Easter: in lieu of all service except special service. For this Grant Herward pays to Dacus as an acknowledgement or Fine half a mark of silver. Dacus ratifies the agreement by setting his Seal to the Deed—In the presence of Gilbert Dacus, Thomas of Cirencester, Robert Triz, Geoffry of the Hospital, Willin Raffe, William of Gedding, Henry Carter, Richard the Clerk, who drew up the Deed; and many others.

Nore.—The Charter of the Borough of Hehester will assist in fixing the approximate age of this MS. In this Charter, granted by Philip and Mary, earlier Charters are cited; and this extract from one of them is quoted—"King John gave to William Daeus a partel of the Town."

#### No. 2, undated-Henry III.
