## CHAPTER II.

Arthur Schopenhauer born at Dantzic, 22nd February, 1788 ; Dutch extraction ; national characteristics inherited even on alien ground ; inherits the Dutch mercantile pride ; ancestors ; father ; mother ; their home life ; birth ; early years ; Dantzic merged in the Prussian kingdom ; history of Dantzic ; the Schopenhauers move to Hamburg, 1793 ; influence of the Dantzic republican spirit ; an inverted education—experience preceding books ; his father's view of a commercial education ; goes to Havre, 1797 ; returns to Hamburg, 1799 ; school there ; dislikes the prospects of

a commercial life ; declines the alternative offered by his father ; starts with his parents on a tour through Europe, 1803 to 1805 ; three months at a Wimbledon boarding-school ; early traits of character, and impressions of his journey ; enters a merchant's office at Dantzic, 1804, and at Hamburg, 1805 ; attends Gall's lectures on mental physiology ; death of his father, April, 1805 ; his mother goes to Weimar, and becomes a social and literary success ; he comes under the influence of Romanticism ; Romanticism defined ; dissatisfaction with life ; his mother agrees to his retiring from mercantile life ; his gratitude to his father . . . . .	22

## CHAPTER III.

Development of classical studies—especially of Greek—in the early years of this century ; Schopenhauer goes to school at Gotha and Weimar, 1807 ; his enthusiasm for the classics ; his strained relations with his mother, due to their opposite characters ; his personal property ; enters University of Göttingen, October, 1809 ; the position of philosophy at the time ; his views of Plato and Kant ; life at Göttingen ; meets Wieland ; moves to University of Berlin, 1811 ; his contempt for the " university professor " ; the charges of plagiarism made against him ; the contrast between him and Fichte ; on the rise of Prussia against Napoleon, he moves to Rudolstadt, 1813 ; takes his Doctor's degree at Jena ; publishes as his Doctor's essay " A Philosophical Treatise on the Fourfold Root of the Principle of Sufficient Reason," 1813 ; its qualities and method ; returns to Weimar ; further and final disagreements with his mother ; who was to blame ? his views on the heredity of the Will and Intellect ; Goethe's theory of Light ; he seeks Schopenhauer's support ; the latter moves to Dresden, 1814 ; his essay " On Vision and Colours " (published, 1816) . . . . .	55

### CHAPTER V.

"The World as Will and Idea": it is the exposition, not of a system, but of a single idea; its style; not an academic discourse, but the gospel of a true life; Schopenhauer wages war against the materialistic philosophy of the scientists; the chief place in philosophy belongs, not to the intellect, but to the will—the system of feelings and desires; the "realities" of science being mere appearances (ideas), science can never give a final explanation of reality; the true philosophy connects ideas with reality, its fundamental principle being the identity in man between the perceived (material) body and the felt (immaterial) will; this principle discussed; its application to the universe at large; the Will as a metaphysical power; by his possession of intellect man has lost his original fellow-feeling with all things, but by it he can regain that unity of feeling; in the artistic genius this unity of feeling finds fullest expression; the function of art is to reveal this unity of existence; man's ignorance of this unity results in his selfish quest of happiness and consequent wrong-doing, which law can do no more than curb; it is the function of morality to purge the individual will of its egoism; the highest life is that of the man who, dead to the lust of life, has ascended from the natural to the Spiritual Will . . . 113

### CHAPTER VI.

Contemporary enthusiasm for Italy; Schopenhauer visits Italy, 1818; his life there; financial trouble; his characteristic conduct in the matter; becomes college lecturer at Berlin, but fails, 1820; jealous suspicions of his rivals; his ill-
