AT the General Assembly of the Province of New Brunswick begun and holden at Fredericton on the twelfth day of February Anno Domini one thousand eight hundred and sixty two, in the Twenty fifth Year of the Reign of Our Sovereign Lady Victoria, by the Grace of Gon, of the United Kingdom of Great Britain and Ireland, Queen, Defender of the Faith, and from thence continued by several prorogations to the twelfth day of February, one thousand eight hundred and sixty three; being the Second Session of the Nineteenth General Assembly convened in the said Province.
