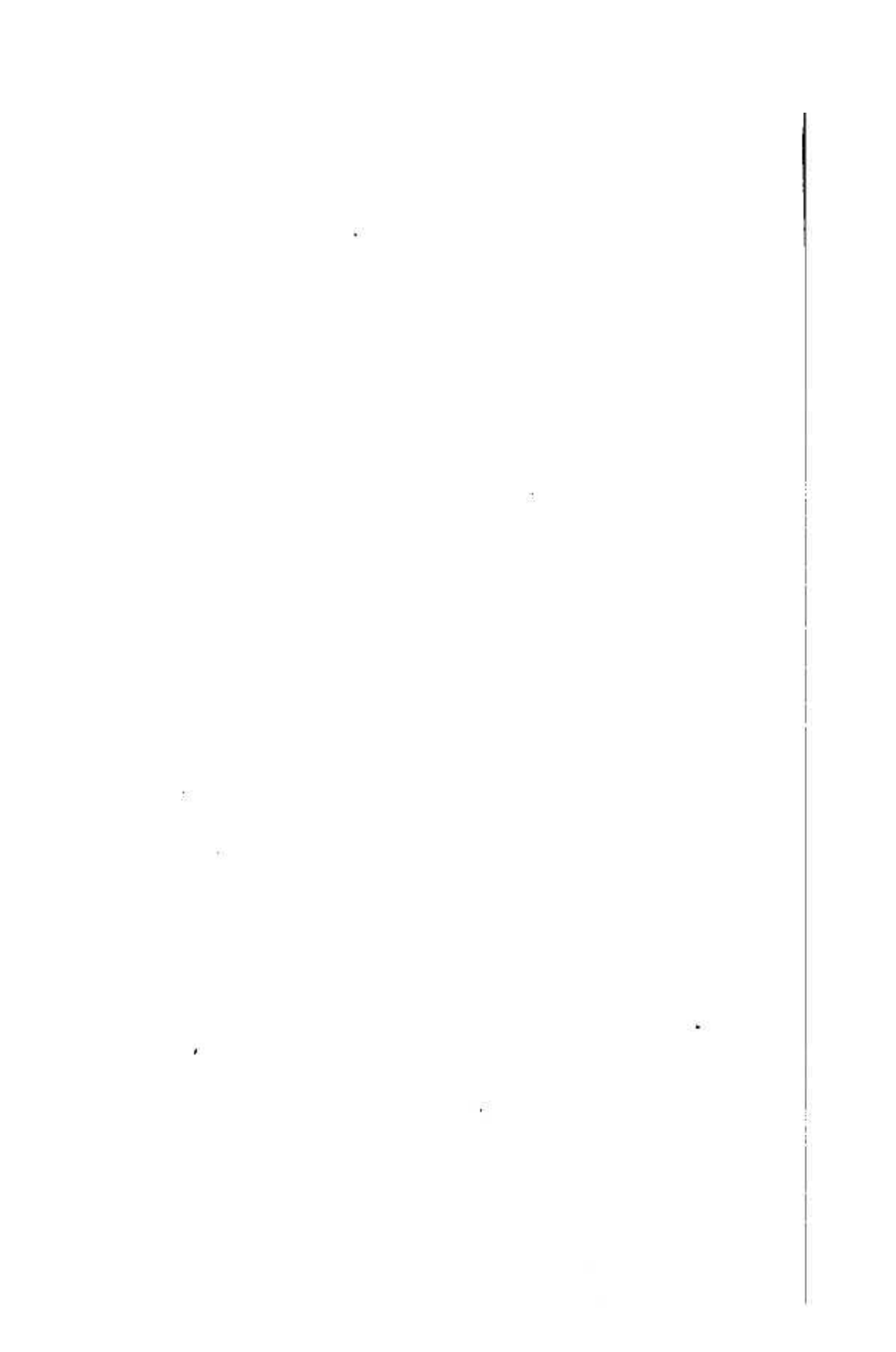

PETITION FOR INCORPORATION

TO THE ST. LOUIS CIRCUIT COURT :

The undersigned members and officers of the society called "The Bar Association of St. Louis," respectfully represent to this honorable court that said society was established to maintain the honor and dignity of the profession of the law, to cultivate social intercourse among its members, and for the promotion of legal science and of the administration of justice; that for that purpose and with that object they have organized themselves into an association under the above name and adopted articles of association, which articles of association are as follows :
