The previous self-examination, while humbling the sinner, will increase his desire to confess—The Act of Confession should be performed as a solemn religious Ordinance—First, Prayer should be made; then the penitent, on his knees, before God, should recount, in the hearing of the Priest, his sins against God's Commandments, testing himself closely by each; also by the seven deadly sins, and by the temptations of the World, the Flesh, and the Devil—He must neither conceal or extenuate, but, with humble contrition, confess all	78

Confession is followed by Absolution; not necessarily, if the Minister doubts of the contrition of the sinner; but if there is reasonable hope that he is truly penitent, we have no reason to doubt that sins remitted on earth are remitted in Heaven—Objections to this statement considered—Confession and Absolution the ordinary mode of Repentance	93
