##### § 1. *Pictures and Narratives*, p. 1.

Ideal sketches, pose drawings, and drawings from nature.—Unnaturalness of the Crucifixion narrative.—Hence supposed by some to be an ideal sketch.—Why the representation can be best explained as a dramatic scene.—Objections anticipated.

##### § 2. *Some Sacrificial Theories*, p. 11.

Complex character of the Crucifixion.—Lord Beaconsfield contends that it was no crime.—The Rev. Dr. Bartle affirms that Christ was necessarily the author of his own death.—These theories, while they tend to clear the Jews from guilt, are totally at variance with the Jewish religion.

§ 3. *Origin of Sacrifices*, p. 15.

Tributary offerings of the nature of bribes.—They fall into discredit as people get more enlightened.—Expiatory sacrifices originate from the custom of tribal retaliation.—Children and slaves selected as victims.—People did not immolate themselves till they believed in a future existence.—The Jews only took their own lives when they would otherwise be slain by enemies.—A hypothetical case of Jesus sacrificing himself to save his countrymen from bloodguiltiness.—The immolation at Calvary of an entirely opposite character.

§ 4. *The Schooling of Jesus*, p. 23.

Every teacher must first be taught.—John the Baptist's influence on Jesus.—He is probably moved by dramatic visions to suffer death.—He applies to himself Isaiah's description of the afflicted nation.—He escapes from Ritualists and is captured by Mystics.—Messiah-worship leads to the construction of a new theology.—The Father sacrificing a good Son for his servants' transgressions.—Jesus morally lowered by a mistaken idolatry.

§ 5. *Vicarious Atonement*, p. 34.

Dr. Herman Adler's declarations on the subject.—Demoralising tendency of the superstition.—The unenlightened prefer favour to justice.—All wrong-doing requires correction.—Mr. Gladstone's defence of the doctrine considered.

## CHAPTER II.

## THE PLAIN PASSION-DRAMA.

§ 1. *Nazarene Asceticism*, p. 40.

The old Jewish doctrine that people are dealt with equitably in the present life.—Origin of the idea that present ills and wrongs are corrected in a future existence.—It induced many to court poverty and pains that they might so become entitled to recompense.—A reversal of human fortunes expected in the Kingdom of Heaven.—Austerities practised by early Christians.—St. Simeon Stylites and others.—Penance made the substitute for persecution.



§ 2. *Assisted Penances*, p. 49.

The crucified Convulsionaries.—Profitable suffering from either friendly or hostile hands.—The Messiah was to be abased on earth or he could not be exalted in Heaven.—The treatment of Jesus outrageous as a punishment, but reasonable as a penance.—A dramatic penance of the Dominicans.

§ 3. *Transfiguration and Trial*, p. 54.

Dramatic action passing for natural action.—Anánias and Sapphira struck dead.—Apparition of Moses and Elias on the mountain.—What the real Moses would have been likely to do on returning to life.—Value of the apparition as a means of conferring on Jesus authority.—His hostility towards those who held a ruling position.—Dramatic acts on approaching and entering the city.—The mysterious arrest.—The rôle of Iscariot.—The trial of Jesus evidently a mock trial.—Remarks of Dr. Benisch and Dr. Geikie on the subject.—Some criticisms of Keim.

§ 4. *The Resurrection*, p. 67.

The greatest Christian miracle losing credit.—On what grounds a general resurrection was anticipated.—Unreasonable demands produce a fictitious supply.—Incompleteness of resurrection miracles.—In the raising of Lazarus and others, no proof of death.—In the rising of Jesus, no proof of identity.—If crucified by enemies, they would not have surrendered the body.—Joseph commanded the garden and all who moved therein.—An exhibition of wounds as vouchers of identity denotes a want of the true natural features.—Theory of a change of clothes preventing recognition.—M. Renan's theory of subjective visions.—The concert of crafty and credulous minds.—Propagandist stratagems of the author of "Daniel," and the rich Arimathæan.

## CHAPTER III.

## THE CLOAK OF MARTYRDOM.

§ 1. *The Significant Silence*, p. 84.

Mistake of Isaiah as to the suffering of captive Israel, and the further mistake of Christian interpreters.—The slender testi-

mony on which the Crucifixion charge rests.—The inference now drawn from the silence of contemporary writers in reference to the accompanying prodigies.—Had the Calvary transaction been a great public spectacle it could not fail to provoke wide and general comment.—Jews and Romans silent respecting it.—Forged testimonies of the third century.—What Josephus says of Pilate's procuratorship.—The Samaritan accusation.—The Pilate of the Gospels and Christian legends.—His report of the Crucifixion spurious.—A genuine report, having so much value as a controversial weapon, would not have been allowed to perish.—How Pilate would have acted had he known of the proceedings at Calvary.

§ 2. *Character of the Accused*, p. 96.

The evidence of character in criminal charges too much overlooked.—The Evangelists weighed against the Jewish Sanhedrin.—Why the Jews were in bad repute with Greeks and Romans.—The educational work of the Sanhedrin.—That college evidently an improving body.—M. Renan's baseless charges against the family of Annas.—Religious persecution then impracticable.—The Roman toleration.—The alleged "persecutions" in the Book of Acts.

§ 3. *Character of the Accusers*, p. 106.

Christian writers addicted to calumny.—Dean Stanley's remarks on monkish chroniclers.—The early fictionists and mystics.—The canonical Gospels.—Calumnies of the second century.—Diabolism and the martyr-spirit conducive to intolerance.—Persecution considered necessary for the perfection of saintship.

§ 4. *The Prophet-killing Charges*, p. 113.

The Gospels misrepresent Jewish history.—The prophets opposed one another, and were not in general treated unjustly.—The people suffered more wrong from prophets than they inflicted on them.—Sectarian prophets slain in times of religious strife.—Prophets liable to ill-treatment when they became political partisans.—Those who spoke as sages and moral reformers had nothing to fear.—The intemperate declamation imputed to Jesus.

§ 5. *Mythical Saint-slaying*, p. 119.

The massacre of the Bethlehemites clearly mythical.—Conflicting statements respecting John the Baptist's death.—The

reasons for which he was probably executed.—The story of Stephen's martyrdom.—The speech ascribed to Gamaliel.—A pretended Gamaliel discovers Stephen's relics.—The mild Herod Agrippa charged with killing the apostle James.—The legendary martyrdom of James the Less.—The alleged crucifixion of Peter, and the beheading of Paul.—Story of St. Mark's cruel death at Alexandria.—Dean Milman on Apostolic martyrdoms.

§ 6. *The Crucified Children*, p. 130.

The conflict between Christianity and Paganism.—When the Pagan population was at length converted, more attention was directed to the Jews.—Why they were supposed to slay children.—Fictitious evidence against them.—St. Simon of Trent.—St. William of Norwich.—Extravagant stories told by Jewish renegades.—The boy flogged to death at Inmestar not a typical case.—Anti-Jewish prejudice partly dispelled by the Reformation.—Incriminating stratagems still practised against them.—The compromising Protestant position.—The mediæval charges compared with those advanced by the primitive Church.

§ 7. *No Motives for Murder*, p. 144.

People never band together to take life without strong motives.—Dr. Benisch's remarks on the absurd charge of blasphemy against Jesus.—The supposed hostility of the Jewish sects.—No reason ever given for Saul's furious antagonism.—Dean Milman's attempt to explain the animosity of the Scribes, Lawyers, and Pharisees.—The theory of a great national disappointment.—A warrior Messiah would not have been welcomed at that period.—The Romans could have no better reason than the Jewish authorities for sending Jesus to execution.—Remarks of Dr. Strauss on the alleged influence brought to bear upon Pilate.—A governor, whom bad men could use as a tool, must have been an imbecile.

§ 8. *Clear Motives for Calumny*, p. 156.

The Jewish authorities were a hindrance to Nazarene proselytism, and could only be discredited by calumny.—Fiction and the drama as instruments of sectarian slander.—All rival sects resorted to defamation.—Canon Robertson on the false charges made against the early Christians.—The advantage which
