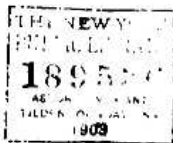

JOINT RESOLUTION TO PRINT THE EULOGIES UPON EDWARD J. GAY.

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That there be printed the eulogies delivered in Congress on the late EDWARD J. GAY, a Representative in the Fifty-first Congress from the State of Louisiana, twenty-five thousand copies, of which number six thousand copies shall be for the use of the Senate, and nineteen thousand copies for the use of the House of Representatives; and the Secretary of the Treasury be, and he is hereby, directed to have printed a portrait of the said EDWARD J. GAY to accompany said eulogies, and for the purpose of engraving and printing said portrait the sum of one thousand dollars or so much thereof as may be necessary is hereby appropriated out of any moneys in the Treasury not otherwise appropriated. That of the quota to the House of Representatives the Public Printer shall set apart fifty copies, which he shall have bound in full morocco with gilt edges, the same to be delivered when completed to the family of the deceased.

Approved, January 28, 1891.

PROCEEDINGS IN THE HOUSE OF REPRESENTATIVES.

ANNOUNCEMENT OF DEATH.

DECEMBER 12, 1889.

Mr. WILKINSON. Mr. Speaker, it becomes my painful duty to announce to the House the death of my late colleague, Hon. EDWARD J. GAY, who was a Representative from the Third Congressional district of Louisiana in the Forty-ninth and Fiftieth, and a Representative-elect to the Fifty-first Congress. Later on in the session I shall ask this House to take appropriate action in regard to the death of my deceased colleague. I now send to the Clerk's desk, and ask the reading and immediate adoption of these resolutions.

The Clerk read as follows:

Resolved, That the House has heard with profound regret of the death of Hon. EDWARD J. GAY, late a Representative from the State of Louisiana.

Resolved, That the Clerk be directed to communicate a copy of this resolution to the Senate.

Resolved, That, as a further mark of respect, the House do now adjourn.

The resolutions were unanimously agreed to; and accordingly (at 2 o'clock p. m.) the House adjourned until Monday next.



EULOGIES.

MARCH 22, 1890.

The **SPEAKER**. The hour has arrived which has been fixed by order of the House for the delivery of eulogies upon Hon. **EDWARD J. GAY**, late a Representative from the State of Louisiana.

Mr. WILKINSON. Mr. Speaker, this is the hour set apart for paying tribute to the memory of my deceased colleague, and now, on behalf of the delegation from Louisiana, I send to the desk a series of resolutions to be read by the Clerk.

The resolutions were read, as follows:

Resolved, That the business of the House be now suspended, that opportunity may be given for tributes to the memory of Hon. **EDWARD J. GAY**, late a Representative from the State of Louisiana.

Resolved, That, as a further mark of respect to the memory of the deceased, and in recognition of his eminent abilities as a distinguished public servant, the House at the conclusion of these memorial proceedings shall stand adjourned.

Resolved, That the Clerk communicate these resolutions to the Senate.

Resolved, That the Clerk be instructed to communicate a copy of these resolutions to the family of the deceased.
