THE EPIDEMIC OF 1889-1890. FRANCE.

Influenza recognised in Paris in November, height of epidemic in December. Influenza imported to Montpellier from Paris, and isolated cases preceded the epidemic. Imported into Frontignan from Paris; to Montbéliard from Neuchâtel and Solenre; to Vergèze from Lunel. Dr. Antony and M. Barth on contagion in hospitals. Spread by contagion on the "S. Germain." "Bretagne" infected by contagion, ships moored near escaped	54-61

CHAPTER IX.

THE SPREAD OF INFLUENZA IN ENGLAND IN
1889, 1890, 1891.

Dr. Buchanan reported cases in October; Dr. Shelly in November. Epidemic in Westbourne Grove and Hammersmith in December. Outbreak at the General Post Office and at Dr. Barnado's Homes in January. Casualty patients at St. George's Hospital. Epidemic at Broadwood's Factory. Colchester, Canterbury, Chelmsford, Cardiff, and Oxford affected in January. Isolated cases existed before there was an epidemic.

Outbreak at University Press, Oxford. Isolated cases at Bristol, Birmingham, and Sheffield in January; epidemics followed. Cases imported into Liverpool from London. Nottingham affected in January, height of epidemic in February. Manchester affected in November 1889, height of epidemic in February 1890. Inverness, Stourbridge, Trowbridge, Wimborne, St. Ives, and in the rural parts of Derbyshire affected in February; Wales in March. Imported into Churchingford from Paris in December 1889, and in February from surrounding towns. Scattered cases during summer and autumn 1890, and winter of 1890-1891. Imported into Hull from New York, March 1891, spread to Sheffield and London. Cases of spread by contagion. Outbreaks at Haileybury School	62-89

CHAPTER X.

PRISONERS AND THE INFLUENZA EPIDEMIC.

In 1803 the inmates of Ryegate Workhouse, Hereford Asylum, and Worcester Jail escaped the epidemic, and in 1889 the nuns of Charlottenbourg escaped the epidemic. At Morningside Asylum isolated cases preceded the epidemic. The prisoners escaped influenza at Bodmin, Ipswich, Kendal, Knutsford, Lewes, Norwich, and Portsmouth, although it was raging in these towns. The records of the Scottish prisons show that in none of them was there a "sudden visitation." - - - 90-102

THE SPREAD OF INFLUENZA BY PARCELS.

Dr. Mease's case (1782). Cases of Dr. Danguy des Deserts, Mr. Bernard, Dr. B. Thorne, Drs. Guiteras and White, Professor Schauta's case. The spread of influenza by parcels is not proved by any of these cases - - - 103-109

CHAPTER XII.

THE INCUBATION PERIOD OF INFLUENZA.

In M. Antony's cases the period varied from one to four days; in Dr. Bordone's cases from two to five days; in Dr. Tueffart's it was four days in two cases and five days in one case. In two cases reported by Dr. Védel it
