The File consists of a piece of tough tinted manilla, folded in book form, on the third page of which is securely fixed a flexible metal clip with two points, on which the papers are placed after being perforated with a punch supplied for the purpose, the Twin Clip is put through the reverse way, the points are then bent down outwards, and the filing is complete.



The Files, which only take up the room of the papers themselves, have expanding backs—which open out with the growth of the contents, the capacity of each File being from 300 to 350 papers—and only cost 4d. each.

### Cabinets for receiving the "Justso" Files.

Where a large correspondence is being dealt with it is of course necessary to have receptacles of some sort to keep the Files in. The "Justso" Filing Cabinets are supplied on the building-up system; a start can be made with one, containing only two divisions, and this can be added to as necessity arises.
