## Preface.

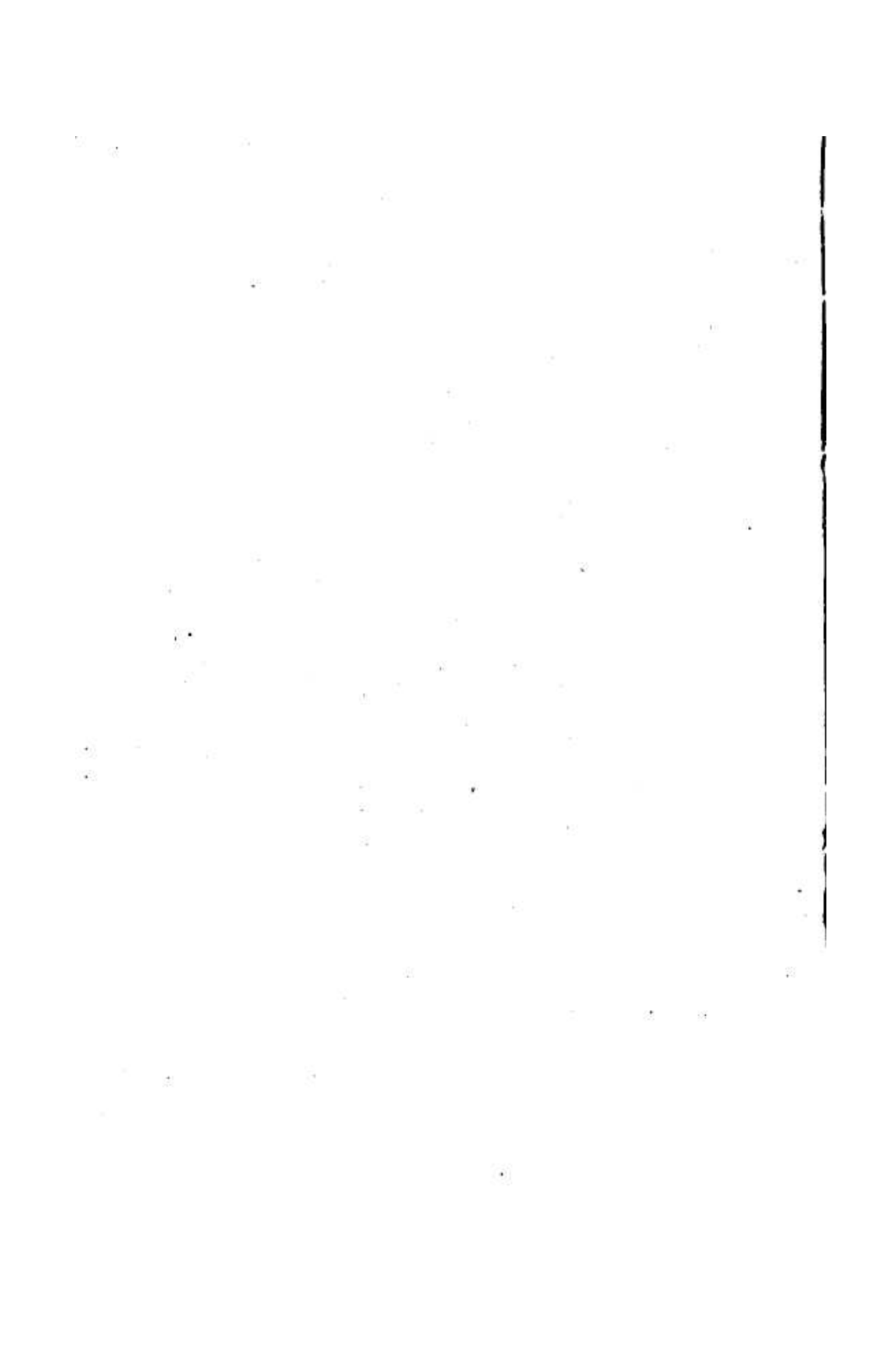
