# STATEMENT, &c.

At a MEETING of the COMMITTEE of IN-HABITANTS of Edinburgh, regarding the Buildings on the West Side of the North Bridge, held within the Royal Exchange Caffee-house, on Thursday, the 12th day of February 1818 years, in consequence of Notes of Intimation from the Convener, of yesterday's date,—

Sir James Fergusson in the Chair,

Mr. STUART reported, that, agreeably to the directions of the last meeting of the Committee, held on the 4th instant, he had, on that day, transmitted to the Lord Provost a letter, in the following terms:—

" 2, North Charlotte Street, 4th Feb. 1818.

## " My LORD,

"The communications which took place be-"tween your Lordship and the Committee ap-" pointed by the Meeting of Inhabitants, imme-" diately after their appointment, on 2d Decem-"ber last, have, I trust, convinced you and the " Town-Council, that our wish from the begin-" ning has been to obtain our object, the reduc-" tion of the height of the Buildings on the west " side of the North Bridge, with the least possi-" ble sacrifice to all parties concerned, and not to " adhere pertinaciously to what we conceive to " be our rights, if our waving them could con-" tribute to prevent the permanent injury to "the City, of which we complained. We at "once agreed to take into consideration the "terms of adjustment which your Lordship "mentioned as being proposed by the Builders " or Sub-feuars to you, although, in doing so, " we exceeded our powers. But we were ready " to incur some degree of responsibility to our " Constituents, that we might be able to prove " to them, and to the Public, that our measures

"had been pursued with that regard to mode"ration which our Constituents had recom"mended to us. Our meetings with your
"Lordship and the Council, and all hopes of
"extrajudicial settlement, were put an end to,
"by your informing Mr. Nairne and me, early
"in January, that you were now resolved, in
"the first instance, to await the decision of the
"Court.

"The opinion of the Court has accordingly been obtained; and, although two of the Judges saw grounds for refusing the Bills of Suspension, on account of the lateness of the period when our challenge was brought, the whole Court agreed in thinking, that the act of Parliament could not, by implication, take away the servitudes to which the charters granted after the decreet-arbitral entitled us.

"Immediately after the decision, yesterday," I thought it right to summon the Committee to meet to-day, to consider what our future proceedings should be. It is now my duty to inform your Lordship, generally, what their resolutions have been; and I trust you will find them to be dictated by the same spirit of conciliation which has hitherto marked our conduct.

"We take it for granted, that, if the deci-"sion of the Court in passing the Bills be ulti-"mately confirmed, no buildings whatever can

"be erected on any part of St. Anne's Street, " under the powers of the existing Act of Par-But we are willing to withdraw all " liament. " legal proceedings, on condition that the Town-"Council and the Feuers agree that there shall " be only a building not higher than fifteen " feet above the causeway of the Bridge, with "a flat roof; that the southmost tenement. " only lately begun, and the most objectionable " of the whole, shall not be erected; and that "the building to remain, the south front of " the presently erected southmost building, and " building to be erected with a proper sweep " or turn on the east side of Mackay's Hotel, " shall be finished agreeably to a plan, to be " settled with a due regard to the interest of "the Public and c the Builders, by the Lord " President, the Lord Justice-Clerk, Sir Wil-" liam Rae, Bart. Henry Mackenzie, Esq. one "member of the Town-Council, to be named " by them, and one member of the Committee, " to be named by the Committee. "In case this arrangement be adopted, it "will fall on us to be responsible that the Sus-" penders withdraw the suits. The subject "has, I may add, been fully discussed by us. "We are aware of many inconveniences at-" tending even the erection of a row of shops "on the North Bridge; but we trust, that "the preservation of the striking views from

"the Calton-hill road and from Prince's Street, "and the removal of a considerable part of the "unseemly pile of Buildings now visible from "Prince's Street, will induce the public to be-"lieve, that, in the proposal we make, we have "neither been inattentive to their interest, nor "acted inconsiderately towards the other parties concerned.

"We are happy to find, by Mr. Claud Rus"sell's Report to the Court of Session, dated
"12th November last, and which is now in
"our hands, that the Town are possessed of
"very large funds, at least of a sum amount"ing to between 9 and £12,000, applicable
"solely to the improvement of North Bridge
"Street. This sum, and the amount of the
feu-duty, which, we formerly understood, th
"Town was willing to abate, will, we doub
"not, go far to indemnify the Town for th
"chaims of the Feuers on them, supposing this
"agreement to be gone into.
