A wish to approach those who have filled distinguished parts on the theatre of human action, and to judge them independently of the *prestige* with which circumstances may have surrounded them, seems to be deeply implanted in the human breast. And among the anticipations with which the American traveller approaches the old world, there is none, perhaps, which promises him more gratification, than this hope of being able to survey more nearly the eminent men, of whose claims to renown distance of space enables us to judge with as much impartiality, as distance of time will enable posterity. I have forgotten neither your wish, nor my promise, that I would communicate to you the
