## PREFACE TO THE SECOND EDITION.

IN this edition the rules and forms made for the purposes of the Bill of Sale Act, 1878, have been added, and the numerous and important cases, both upon the Act of 1878 and the Acts of 1854 and 1866, which have been decided since the appearance of the former edition, have been worked into the notes. The repealed Acts, which in some cases are still in force, are set out in an appendix.

The precedents have been revised, and to some extent divided into paragraphs, with a view to simplicity. In this arrangement many hints have been taken from the Conveyancing and Real Property Bill introduced by Lord Cairns, which will be found in the supplement to the *Weekly Notes* of the 6th of March, 1880.
