PRELIMINARY NOTE.

THE following Tract consists of a series of papers published by the writer in Book Notes, during the autumn of 1894, very much enlarged, but upon the same lines. The question was not one of the establishment of the principle of Religious Liberty here in Rhode Island, but whether such a principle had been already established, and then existed in Maryland when Rhode Island was planted, in 1636; whether the Roman Catholic Church in Maryland planted Religious Liberty before Roger Williams planted this principle here in Rhode Island.
