REPORT OF THE COUNCIL

67

The Pipe Roll Society.

Read at the Committee Meeting on the 24th April, 1896.

THE present Volume, Vol. XX., is a continuation of Vol. XVII., which was issued in 1894, and contained a collection of the Feet of Fines of the reigns of Henry II. and Richard I.

In this volume are printed two Feet of Fines for the 7th year of Richard I., found since the last volume was printed, and those for the 8th year of the same King, arranged in chronological order, according to the system adopted in Vol. XVII. At some future time, the series will be continued to the end of the reign of Richard I.

The next volume, which will also be issued in return for the subscriptions for 1895-6, will consist of the Pipe Roll for the 20th year of Henry II., and notice will be taken of the principal variations between that Roll and the Chancellor's Roll for the same year. A considerable portion is already in type.
