### ANNOUNCEMENT.

During the preparation of a new edition The Lawyer's Reference Manual has been allowed to go out of print.

The author finds the work of revision so slow that he here reprints for the use of lawyers and students, until the second edition can be completed, that portion of the manual which is most constantly needed.

As the law literature of the last fifteen years is well known to the present generation, this Index of Abbreviations, complete up to 1883, will be a practical guide to citations in recent books as well as in reports and treatises published prior to that year.

THE LAWYER'S REFERENCE MANUAL, when revised, will contain:

- I. A list of American Reports, Digests, Statutes, and local treatises grouped by jurisdictions, with notes as to editions and peculiarities.
- II. Lists of English, Irish, Scotch, and British Colonial Reports, Digests, Statutes, and local law books; with notes,—especially full as to the older reports.
- III. A list of English and American elementary works, giving the title—so far as possible—of every law book ever published in the English language, and the date of every edition.

- IV. An Index of Subjects, with the books on each topic arranged chronologically, so as to show the literature of the topic in its historical sequence.
  - V. An Index of Authors, covering the first three divisions.
  - VI. An Index of Abbreviations used in citing law books.

The Manual in its second edition will be much larger than in the first, and will command a price of about \$6.50. The publishers (The Boston Book Co.) invite advance inquiries and orders from all interested in this practical form of legal bibliography, in order to determine the size of the edition to be printed.
