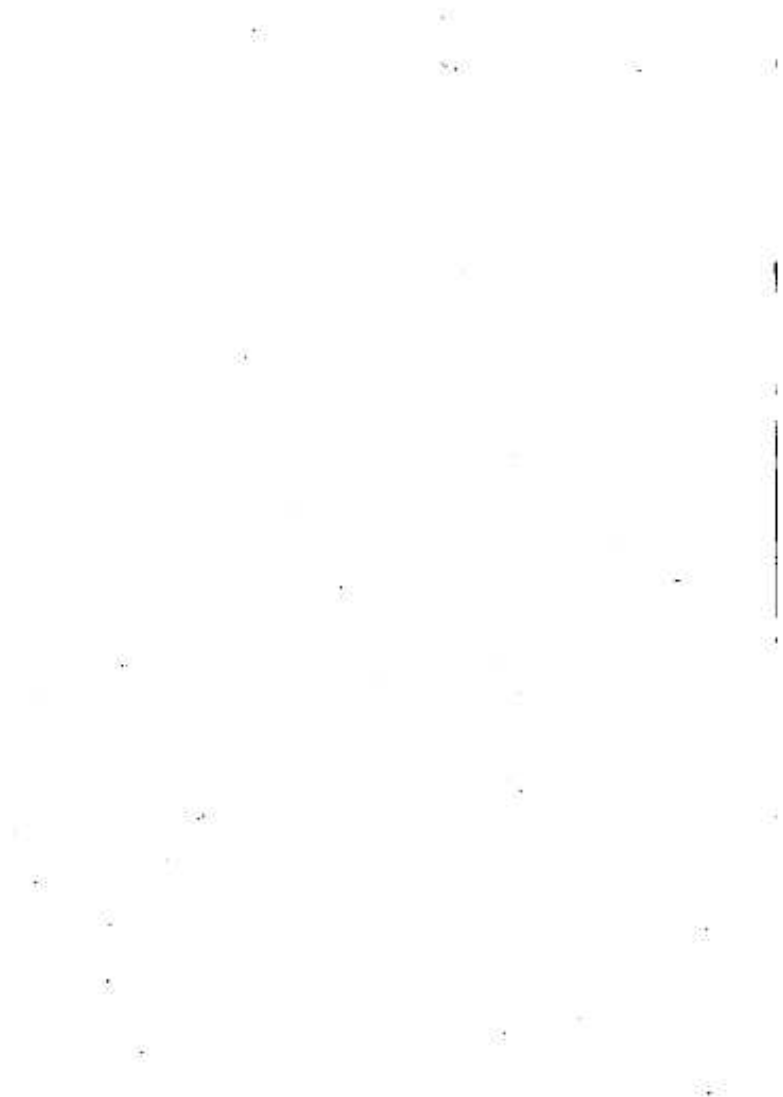


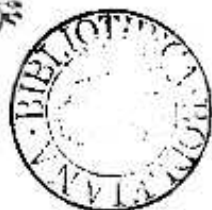
Figure 1. Location of the study area in the southern part of the Iberian Peninsula.
