—Imprimus—All my debts, of which there are but few, and none of magnitude, are to be punctually and speedily paid, and the legacies hereinafter bequeathed are to be discharged as soon as circumstances will permit, and in the manner directed.

ITEM—To my dearly beloved wife, Martha Washington <sup>8</sup> I give and bequeath
the use profit and benefit of my whole
Estate, real and personal, for the term
of her natural life, except such parts
thereof as are specially disposed
of hereafter,—My improved lot in
the Town of Alexandria, situated on
Pitt and Cameron Streets, I give to her &
