

#### A REPORT

OF THE

### RECORD COMMISSIONERS.

The Record Commissioners berewith submit the seventh volume of the publications issued under the authority and at the expense of the City of Boston. It is a continuation of the Town Records from the point at which their second printed volume closed, and includes all the records from March 11th, 1660–1, to March 10th, 1700–1. Up to this latter date the records of town meetings were kept with those of meetings of the Selectmen; from this date they are in separate books. It seemed best to close this report at the point of division, in order that hereafter the Town Records may be printed in one series, and the Selectmen's Records in another. It is unnecessary to point out the value of the volume here presented to the public, but attention may be called to the careful "Index of Places and Subjects," prepared by Mr. John T. Priest, assistant City Clerk, by which reference to the valuable records is so greatly facilitated.

The Commissioners have the material prepared for a volume of the earliest records of births, deaths, and marriages, contained in the records of the Town Clerk and of the First Church, which will be sent to press forthwith. It is also their intention to continue the publication of the Town Records, believing that no more important duty can be found. As this volume has been stereotyped, it will be always possible to supply copies to all persons having any reasonable claim.

Boston March 11th 1660 / 61.

Att a Publick meeting of all y Inhabitants vpon lawfull warning from house to house, were chosen for y' yeare ensuing.

mittee was nominated.

Capt Tho: Savage, Capt Tho: Clarke, Capt James Olliner, Capt Ed. Hutchinson, Ed: Rainsford, M' Edw: Tynge & Tho: Buttolph were chosen a Comittee to draw Instructions for yo select men won are first to bee presented to ye consideration of ye Towne for acceptance & confirmation.

Vpon ye motion of Rich. Gridley & ye rest of ye brick makers in y\* Towne for to rent some pt of y\* Townes land in y\* Comon to make brickes; Itt is ordered yt y\* select men shall accommodate them win whatt land may bee fitt for their vse in ye most conven-

ient place.

[2.] 25: 1. 1661. At a meeting of W<sup>m</sup> Davis, Peter Olliver, John Hull, Tho. Lake, Hezckiah Usher, & Nat Williams, W<sup>m</sup> Davis is chosen Recorder - Nath Williams chosen sealer of weights and measures. - Sargt Tho. Clarke, Theodore Atkinson, Henry Steuens, Ed. Devotion, John Odlin & Ed. Cowell are chosen for perambulation betweene muddy river & Cambridg & betweene muddy river & Roxbury.

Whereas y Pitts by Henry Bridgams were lett to Cap' Johnson for 7 yeares & hee hath this day desired a release of his contract w<sup>th</sup> y Towne, y same being accepted by us, y fore mentioned Pitts are now lett to Henry Bridgam for 7 yeares, hee paying 15 p. annum to y Townes Treasurer.

W<sup>m</sup> Whittwell is licensed to draw beere for this yeare, Goodwife Vpsall bath y<sup>e</sup>. like liberty, Clement Gross bath y<sup>e</sup> like liberty, as

also Wm Pollard.

Itt is Ordered y' no person shall fell any timber vpon any of y' Townes Comons upon panalty of 10° for every tree felled withoutt leave.

Peter Olliuer & Peter Aspinwall are deputed to joyne wth Cambridg men to lay outt a high way from Muddy-river to Cambridg.

It is Ordered y' y' surveyor' of y' high wayes att muddy river shall forthwth repayre y' high way to Water towns mill where itt is defective.

Edward Cowell & Joseph Gridley are chosen to bee execution's of y' Townes orders respecting swine for this years in consideration whereof all fines except forfeitures shall accrue to y' s' ptyes.

8: 2: 1661. Att a generall Townes-meeting upon publick notice from house to house Vpon y\* l'etition of Leiu Rob Turner & Peter Olliner respecting y\* Cedar swamp att Muddy Riuer w\*h. was lett to them by Lease y\* y\* s\*. Lease may bee for ener. Itt is Ordered, y\* Propriety of y\* s\* swamp shall belong to y\*. s\* p'tyes for ener upon y\*. paym' of y\* rent mentioned in y\* former Lease.

In answer to Mr Scottowes petition—It is ordered y\* y\* former Comittee deputed y\* 5-9-60 be appointed w\* such other of y\* ancient select men as Mr Scottow pleases to give answer on y\*

Townes behalfe to ye se peticon.

The Instructions for y<sup>e</sup> select men signed by y<sup>e</sup> Committee appointed to draw them vp, being read, were voted y<sup>e</sup> they should bee in force till new were appointed.
