## PREFACE.

With the issue of the Index, the valuable matter scattered throughout the *Transactions* of this Society becomes available for study.

The present General Index to the first twenty volumes, from 1876 to 1897, has been compiled in accordance with the rules approved of by the Congress of Archæological Societies in union with the Society of Antiquaries, held in London in December, 1897.


It is arranged in one alphabet under names of persons, places, and subjects. Contributors of Papers are distinguished by their names being printed in small capitals under each entry.

On account of the varied character and unequal quality of the Indexes issued with the volumes, they have not been used in the present work; the compiler alone is responsible for this compilation.

Amongst the new features which have been introduced, it is hoped that the one of grouping under subjects the matter relating to places will be found useful.

When the work was commenced, now nearly three years ago, the compiler did not realize its magnitude: as it proceeded, new ideas suggested themselves, and the plan of arrangement had to be altered from time to time to meet special cases.

Great care has been exercised, and much research made, in order to insure accuracy and to make the Index as useful and reliable as possible, but in a work of this kind it has proved impossible to prevent errors from creeping in. The compiler trusts that these will be treated with leniency, and that the work as a whole will be appreciated by the student of Gloucestershire Archæology.
