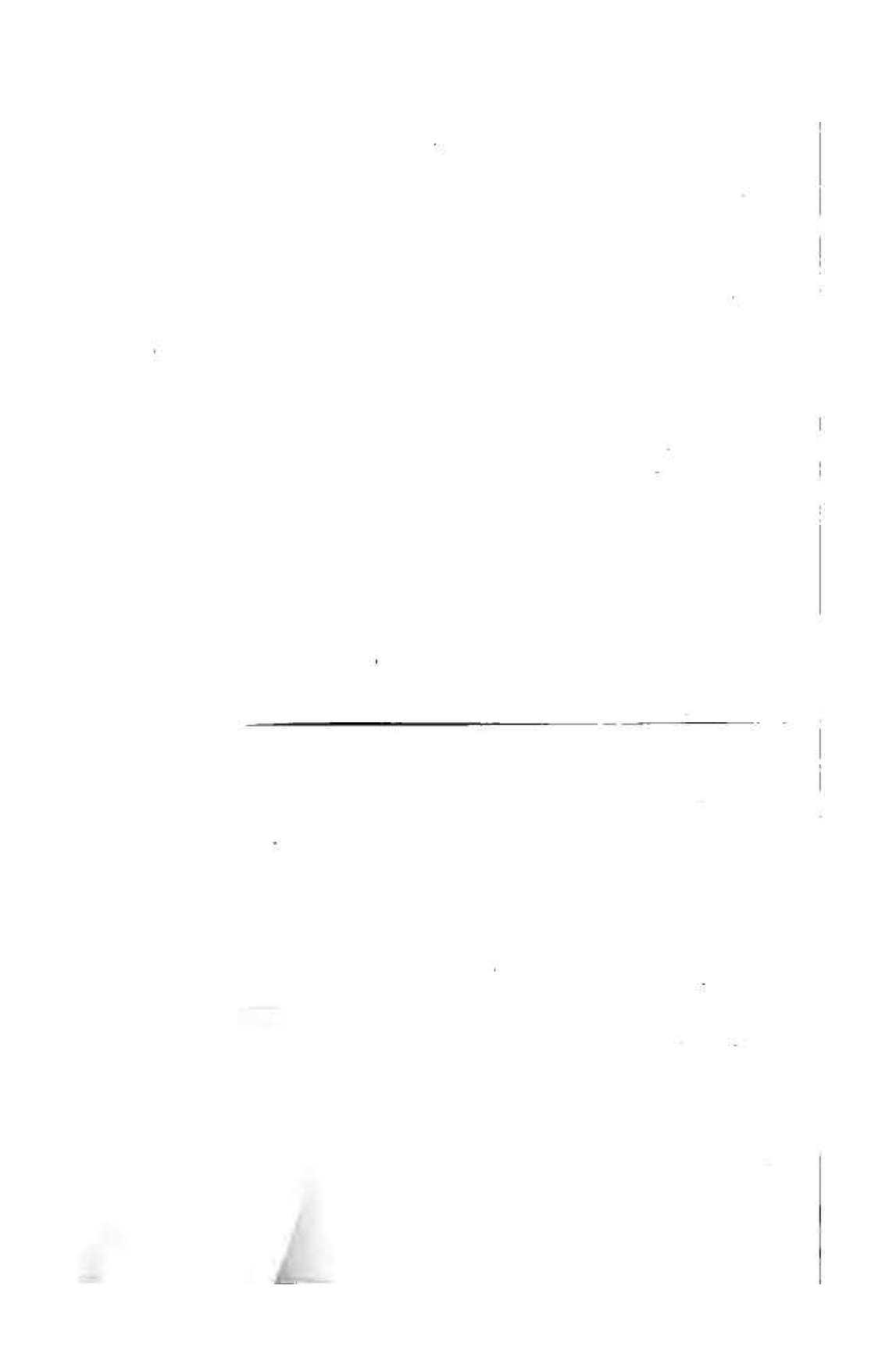

## PREFACE.

---

THE present volume contains a calendar of the deeds relating to the property of the Priory of Selborne in other places than Selborne itself, and thus, in connection with the previous volume, practically supplies a copy of the lost cartulary of that monastery. Of all the deeds belonging to the localities concerned abstracts are given, except in the case of Petersfield, in which many deeds of ordinary character, which are of later date than the suppression of the Priory, ending in 1595, and which consequently have no connection with its history, have been omitted, the Editor having been requested to restrict the contents of this volume to the records distinctly monastic in their own character or in their connection and sequence. Out of a total of 167 Petersfield documents, 37 are here calendared, the remainder being such as relate chiefly to the transfer of property from the family of Squery to that of Rede, and from John Rede, esq., to bishop Waynflete.

To the members of a local society, everything that illustrates the topography and parochial history of their district, and the genealogy of families settled in it, is matter of real interest. And it is in reference to such particulars that this calendar will be found alike to deserve and reward attention. The documents with which it deals being the originals, there are none of the mistakes, omissions, or alterations, which often cause doubts and difficulties with regard to copies in registers; all is authentic. And with the exception of some of the Basing and Basingstoke entries, which have been already made use of in the elaborate history of the latter place by the Editor's old
