We call attention to the following points of advantage possessed by this work :

FIRST. It is prepared especially for use in California, and has the essentials of the law of California, regarding business transactions, embodied in it.

SECOND. It is prepared by a lawyer in active practice in the Courts of California, who has also had some nine years' experience as a teacher.

THIRD. The work contains more law, in less space, than general text books, published for use throughout the United States, in this: that it does not need to state generally what the law is, and then state "that there^{are} numerous exceptions, and the student will have to look at the statutes of his own state in order to find out what the law is there."

FOURTH. The book is written in the concrete, rather than the abstract, and contains numerous illustrations.

FIFTH. The illustrations, so far as possible, are taken directly from reports of cases decided by the

Supreme Court of California, and of other states where the same law exists, so that the illustrations can be relied upon as stating the law correctly.

SIXTH. The book is not padded with an appendix of useless and misleading "forms." A number of the more common and necessary forms are given in the body of the work.

SEVENTH. The work does not deal with generalities, but states the exact law correctly regarding business transactions.

EIGHTH. It is so arranged as to be valuable as a reference book for students after finishing their College course; hence a College should have no second-hand volumes on hand, but can sell new books to each class.

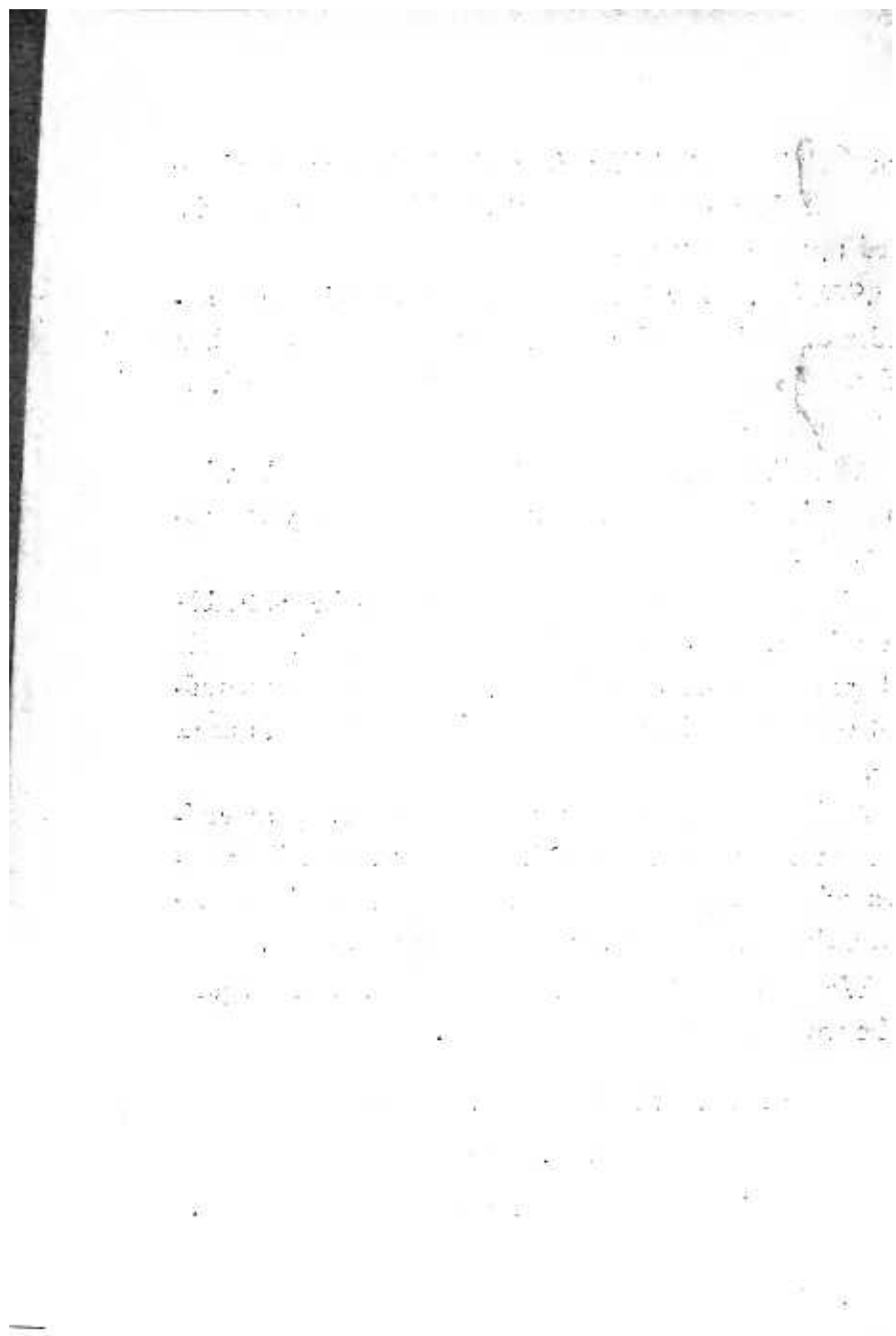
