Archæological-Indian Relics, Etc.

Representative Stone Implements from Virginia, West Virginia, Kentucky and North Carolina, comprising Arrow and Spear Heads, Rough and Smooth Axes, Rough and Smooth Scrapers, Hoes, Hammers, Whorls, Badges, Discs, Knives, Pipes, Bowls and Pestles—Loaned by The Valentine Collection, Richmond, Va.

Fossil Coral from Virginia Beach-R. F. Allen, Prince Edward county, Va.

Kettle (Pottery) from Indian mound, Scraper and Stone Axes, Calcite Stalagmite, Shark's Tooth—E. T. Taliaferro, Prince Edward county, Va.

Several hundred Indian Implements, Arrow Heads, Scrapers, Tomahawks, etc., from Virginia, West Virginia and Colorado— Wm. H. Miller.

Arms, Swords, War Relics, Etc.

Epaulettes worn by Colonel Venable in the Revolutionary War-Major A. R. Venable.

Gun 263 years old, brought over by Dr. John Woodson in 1625. Dr. Woodson was killed by the Indians, and this gun was used by the family in defending the house and seven Indians were killed with it—C. W. Venable.

Two Japanese Swords-Miss Julia W. B. Thompson, Richmond, Va.

Sabre of Colonel W. J. Pegram, Confederate States Army, worn by him when killed—Pegram Battalion Association, Richmond.

Spy-Glass found near Smithfield, Isle of Wight county, on the campground of Lord Cornwallis, in 1781—Dr. John R. Purdie, Smithfield, Va.

Gun of Captain John Ashby of colonial times—B. G. Ashby, Richmond.
Old Confederate Army Cutlass—James Blair, Richmond.

Confederate Cutlass-W. H. Briggs, Richmond.

Sword found in Chickahominy Swamp—Samuel Bowman, Richmond. Arab Dagger in silver-repousse work—Mrs. H. Jacobs, Richmond.

Gold Sword presented to Commodore Ap. Catesby Jones, United States Navy, by the State of Virginia for gallantry—Miss M. C. Jones and Miss M. E. Lee Beall, Washington, D. C.

Sleeve Buttons made from artillery buttons used in the War of 1812— John S. Ewers, Richmond.

Two Old Pistols used in the Revolutionary War-Thomas Guy, Richmond, Va.

English Pistol, over 100 years old-Mrs. W. W. Hopkins, Richmond.

Two Confederate Muskets, made in Richmond in 1863 and 1864.

Two Confederate Swords, made in Richmond during late war.

One Naval Cutlass, C. S. N. on hilt, made in Richmond—O. L. Cottrell, Richmond.

One of the 12 Swords presented to General George Washington, to be given to his most deserving officers (?), and of which Captain William Mason received this.

Brace of Pistols carried by Captain William Mason during the Revolutionary War-Mrs. F. L. Chase, Alexandria, Va.

Sword presented to Captain Wm. Dandridge, of the British Navy, by John, Lord Montague, in April, 1738—Capt. F. W. Chamberlayne, Richmond.

Turkish Scimetar, set in gold, hilt and scabbard Rhinoceros born and hide, presented by Sultan—Sackville W. Caldbeck, University of Virginia, Va.

Sword of Capt. Jno. Dupuy, used by him in the Revolutionary War— Powhatan E. Dupuy, Richmond.

Cannon Ball used in War of 1812-H. Brown Haley, Richmond.

Cannon Ball plowed up in Henrico about 40 years ago, supposed to have been used during the War of 1812—Mrs. M. E. Garthright.

Ten-chambered Revolver, used by a Federal Officer in 1861-Henry Gunst. Richmond.

Box of Flints from the period of the American Revolution—M. L. Tutwiler, Seven Islands, Fluvanna county, Va.

Relics from Battlefield of Waterloo.

Pibroch, used in 1734.

Dirk set with Gold and Stones, showing Knife and Fork sheath, used by an Officer of the 74th Highland Regiment.

Plaid Brooches, used by an Officer of the 74th Regiment.

Sparah, in old Highlander set.

Powder Horn, Brooch, Shoe Buckles and Dirk of an Officer of the 74th Highland Regiment.
