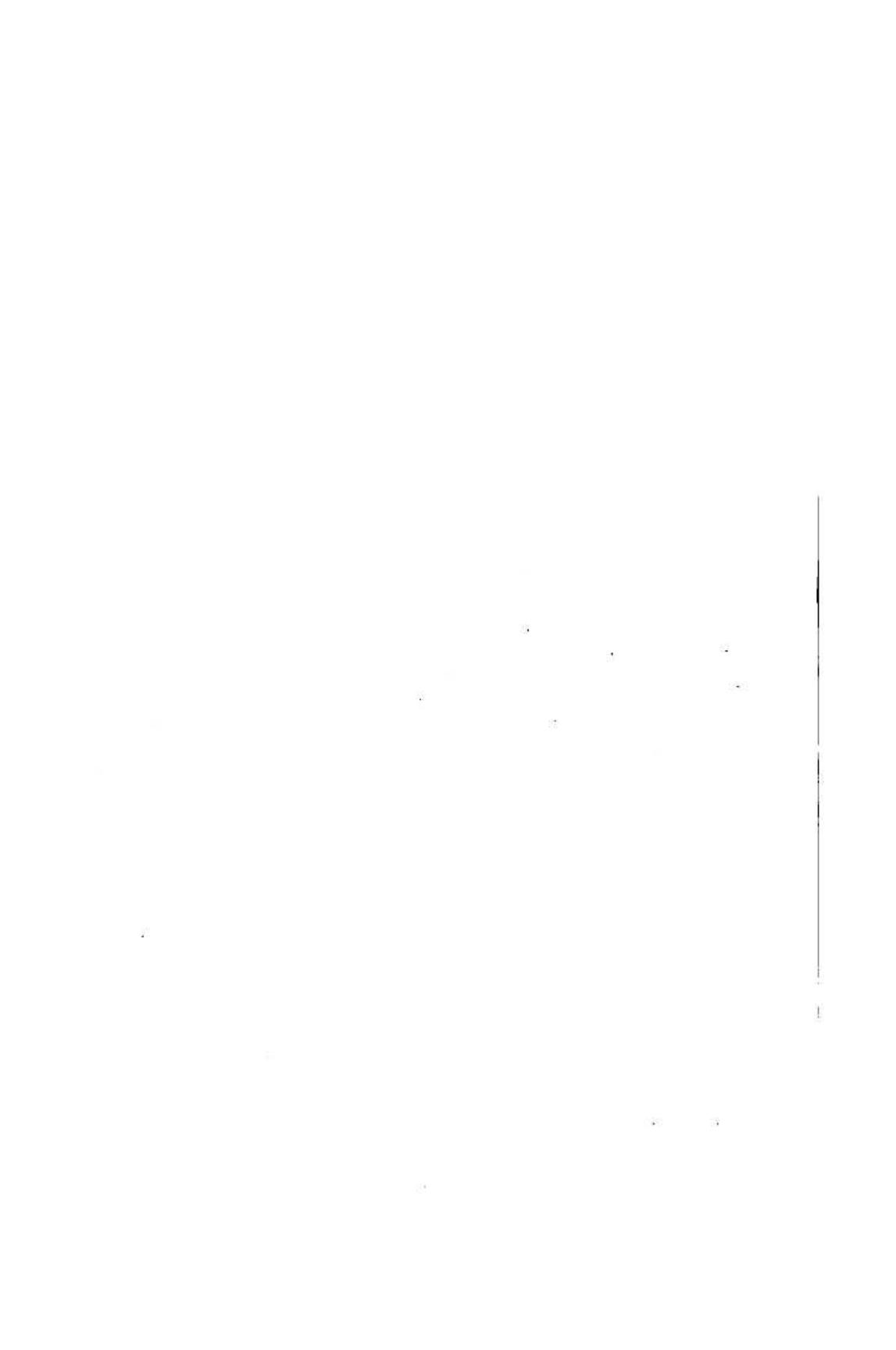

The council of the American Institute of Accountants has authorized the publication of a year-book condensed in form, following the precedent of 1918. The cost and difficulties of printing this year are even greater than last year.

Papers read at the annual meeting have been printed in the October issue of THE JOURNAL OF ACCOUNTANCY, which is the official organ of the American Institute of Accountants.

Since the publication of the last year-book two new C. P. A. laws have been enacted, namely, those of Alabama and Arizona, both of which have been approved by the council of the Institute.

The constitution and by-laws and rules of professional conduct published in this year-book contain amendments and additions enacted during the year. The year-book is distributed without charge to all members and associates of the Institute. Extra copies may be obtained from the offices of the Institute at \$1.50 net, \$1.65 delivered in the United States.
