PREFACE.

THE Register of Bishop Cantilupe had been already transcribed, as a labour of love, by the Rev. R. G. Griffiths, before there was any definite scheme of publication. In the accomplishment of this work he wishes to acknowledge with grateful thanks the great assistance which he has received from Prebendary Hingeston-Randolph, the Editor of the Exeter Registers, to whom he is indebted for his ability to decipher many obscure and difficult portions of the Register, and to whose mature experience the accuracy of the text is due.

The Index is also the work of the Transcriber.

The transcript reproduces the original text with the irregularities and variations of spelling which are especially frequent in case of the personal and local names. These are printed as they stand without any mark to call attention to the inconsistencies of usage. The Register is ill-arranged and some copies of earlier documents are stitched between the pages. Towards the end of it the writing is often indistinct and portions of the text have been torn off or worn away.

It was thought that most readers would prefer to have the modern forms of place-names given in the English abstracts, where they could be ascertained, but this has been done at the cost, to some extent, of uniformity of style, and the risk of possible error due to the lack of familiar acquaintance with a diocese whose boundaries have been shifted in the course of time.

The Editor has to thank Viscount Dillon, who has kindly explained some obscure terms in a passage dealing with Medieval armour, and several friends who have given help in determining such references as required full local knowledge.

Notes have been added with a very sparing hand, as it was not desirable to increase the bulk of the work.

July 10, 1275.—The custody of the Church of Brampton Bryan is committed to Robert de Lacy, acolyte, presented by the Prior of the Hospital of St. John of Jerusalem in England. Mandate to the Bishop's Official to induct him.

BRAMPTONE BRIAN.—Vj Idus Julii, anno Domini M°CC°LXX° quinto, commorans apud Bradewelle, commisit Dominus Thomas Electus Herefordensis Roberto de Lacy, acolito, presentato per fratrem Josep¹ de Cauncy, tunc Priorem Hospitalis Sancti Johannis Jerusalem in Anglia, custodiam² ecclesie de Bramptone Brian usque ad Festum Sancti Michaelis proximo sequens; et mandavit Officiali suo, magistro Luce de Bre, quod eum faciat induci in possessionem ejusdem nomine custodie per eum ad quem ea res pertinet. July 10.—Letters dimissory granted to Robert de Lacy, acolyte, that he may be ordained subdeacon by any Bishop of the Province of Canterbury.

July 16.—The Elect commends to the Chapter Henry Fitz Waryn, appointed by the King, during the vacancy of the See, to the office of Penitentiary of the Cathedral.

July 18.—The Elect deplores the scandals and animosities caused by the two rival claimants to the Deanery, each of whom has appointed a Subdean; he begs the Chapter to use its influence with them that he may not have to resort to stringent measures.
