JAN - 91970 RULES.

- 1.—That the Society shall be called the Record Society, and shall have for its object the transcribing and publishing of Original Documents relating to the Counties of Lancaster and Chester.
- 2.—That the affairs of the Society shall be governed by a Council, consisting of a President and twelve Members, the former of whom shall be annually elected by the Council.
 - That three Members of the Council shall form a quorum.
- 4.—That the subscription of Members of the Society shall be £1 1s. per annum, which shall entitle them to the publications for the year; but any Member whose subscription shall be two years in arrear shall thereupon be removed from the Society, and shall not be re-admitted until all arrears have been paid. The number of Members is limited to 950.
- 5.—That the subscriptions shall be due on the 30th of June in each year, and that no work shall be issued to any Member whose subscription is in arrear.
- 6.—That an Annual Meeting of the Society shall be held in the month of October, of which due notice shall be sent to all the Members. At this meeting a Report of the work of the Society, with a Statement of the Income and Expenditure, shall be presented. These shall be annually published together with a List of Members and the Rules of the Society.
- 7.—That so long as the funds of the Society permit, two volumes at least shall be issued to the Members in each year.
- 8.—That no copies of the publications of the Society shall be sold to non-members, except at an increased price to be fixed by the Council.
- 9.—That no payment shall be made to any person for editing any work for the Society, but that the Editor of each volume shall be entitled to twenty copies of the work so edited by him.
- 10.—That the Treasurer's Accounts shall be audited by two Members of the Society, who shall be elected at the Annual Meeting.
- 11.—No alteration shall be made in any of the above Rules except at the Annual General Meeting. Notice of any proposed alterations must be sent to the Hon. Secretary a month before such General Meeting.
- General Meeting.

 12.—That a Meeting of the Council of the Society shall be called by the Hon. Secretary at least once in every three months.

The Annual Subscription of £1 ls., entitling the Members to all the Volumes issued for that year, may be paid to the Hon. Treasurer, or to the credit of the Society at their Bankers, the Manchester and Liverpool District Banking Company, Limited, at any of their branches.

Report for the Year 1900-1901.

Read at the Council Meeting held in the Audit Room of the Chetham Hospital, Manchester, November 1st, 1901.

Since the last Annual Meeting, held on the 24th October, 1900, two volumes have been issued to the Members. These are volumes 41 and 42. Volume 41 was "Some Court Rolls of the Lordships, Wapentakes and Demesne Manors of Thomas, Earl of Lancaster, in the County of Lancaster, for the years 1929-4." The manuscript was kindly presented to the Society by Mr. Farrer, a member of the Council, who also edited the volume. As Mr. Axon's "Quarter Sessions Records," promised in our last Annual Report as No. 41, was not ready, this volume of Court Rolls was substituted and issued as the second volume for the year 1899-1900.

Volume 42 was the first part of the "Manchester Quarter Sessions Records," and was edited by Mr. Ernest Axon in collaboration with Mr. Charles Sutton. This has been issued as the first volume for the year 1900-1.

The second volume for the same year, at present in the press, is a fourth volume of Miscellanies, a portion of which has been in type for some years. It contains (a) A List of Freeholders for Cheshire, 1578. (b) The Ordination Book of the Diocese of Chester, 1542-1558. (c) Index to recently discovered Wills at the

Bishop's Registry, Chester, 1621-1700. The whole of items (a) and (b) are printed off and more than half of item (c), so that the Council hope to be able to issue this volume very shortly.

As to future work the Council have again to tender their very cordial thanks to Mr. Farrer, who has ungrudgingly placed his splendid store of transcripts at their disposal. Mr. Farrer has not only presented the Society with the transcripts for another volume of Lancashire Fines to follow on volume 39, but has also kindly agreed to edit it. An interesting work, which the Council hope to issue at an early date, is the first portion of the "Court Rolls of the Lordship of Halton," which are being transcribed by Miss Ethel Stokes, who has also kindly undertaken the work of editing.
