CERTIFICATE OF INCORPORATION  
OF  
THE UNIVERSITY ATHLETIC CLUB.

---

WE, GEORGE A. ADEE, GEORGE WALTON GREEN, WILLIAM H. L. LEE, CHARLES F. MATHEWSON, EVERT JANSEN WENDELL, HENRY STANFORD BROOKS, TRACY H. HARRIS, HENRY S. VAN DUZER, EDWARD S. RAPALLO, all persons of full age, and citizens of the United States, and of the State of New York, desiring to form ourselves into a society or club, for social, athletic and kindred purposes, under the provisions of Chapter 267, of the Laws of the State of New York, of the year 1875, and the acts amending the same, do hereby certify, as follows :

I. The Club, or Society, shall be known in law by the name, or title, of "The University Athletic Club."

II. The particular business and object of said Society, or Club, shall be the furnishing of proper apparatus and facilities for athletic and social enjoyment and recreation to the members thereof, and for the encouragement of amateur sport.

III. The number of Trustees to manage said Club, or Society, shall be nine (9), and the names of said Trustees for the first year are as follows :

George A. Adee, George Walton Green, William H. L. Lee, Charles F. Mathewson, Evert Jansen Wendell, Henry Stanford Brooks, Tracy H. Harris, Henry S. Van Duzer and Edward S. Rapallo.

IV. The principal office of said Society, or Club, shall be located within the City of New York, in the State of New York.
