CHARLES WHEATON ABBOT, '49. Born Nov. 18, 1829, at Warren, R. I. Entered Soph. Class, 1846. Oration Commencement. A.B., 1849; A.M. Entered U. S. Navy 1856. First year Civil War on Potomac Flotilla; afterwards in Admiral Farragut's squadron. Served until Nov. 18, 1891, when was retired under age provision as Pay Dir., the highest rank in Pay Corps. Married, Miss Ann F. Abbot, in 1856. Has two children: Annie F. and Charles W. Addr., Warren, R. I. Clubs: not given.

***JOHN PICKENS ABBOT, '49.** Born 1829. Entered Soph. Class, 1846. Left coll. for Bowdoin. A.B.; A.M. (Bow.). Served as Purser in U. S. Navy. M.D. (Harv.), 1886. Practised medicine. Deceased.

***GAMALIEL ZELOTES ADAMS, '39.** Born 1814. Left coll. in 1838; afterwards studied for the Baptist ministry. Author of several poems. Resided at Middletown, Conn. Deceased.

***JOHN R. ADAMS, '49.** Born 1830. Left coll. on account of ill health. Died Aug. 7, 1850.

EDMUND THROCKMORTON ALLEN, '41. Born 1821. Remained only a short time in coll. His last known address was Elizabethtown, N. J.

AUGUSTINE HUGO WELLS ANDERSON, '01. Born July 19, 1874. Entered Jun. Class. After graduating entered Gen. Theo. Sem., N. Y. City.

CHARLES McLEAN ANDREWS, '84. Born at Wethersfield, Conn., Feb. 22, 1863. *Φ. B. K. (hon.)*. A.B., 1884; A.M., 1890. Class Poet. Post-Grad. course and Fellow, Johns Hopkins, Ph.D. (same), 1889. John Marshall Prize, 1893. Assoc. in Dep. History, Bryn Mawr Coll., 1889-1895, Assoc. Prof. (*id.*), 1895-98, Prof. (*id.*), 1898—. Chairman Winsor Prize Com., A. H. A., 1899. Commissioned by A. H. A., Libr. of Cong. and Carnegie Inst., to prepare Guide to documents in England relating to Amer. Col. History. *Author of Historical Development of Modern Europe from the Congress of Vienna to the Present Time, 1815-97; The Old English Manor; Contemporary Europe, Asia, and Africa, 1871-1901; River Towns of Connecticut; Colonial Self-Government, 1652-1685* (being Vol. V. of "The American Nation, a History"), now in process of publication; and of various articles in Reviews and Historical Journals. Married Miss Evangeline H. Walker, at Bryn Mawr, June 19, 1895. Has two children: Ethel and John W. Addr., Bryn Mawr, Pa. Clubs: not given.

*JOHN ANISTAKI, '37. Born in Greece in 1816. Oration Commencement. Was one of the fugitives from the Missolonghi (Greece) Massacre, 1826. A.B., A.M. Resided in N. Y. City for some years, and afterwards moved to Trenton, N. J., where he died Jan. 30, 1872.

ARTHUR EUGENE ARVEDSON, '01. Born in Carpentersville, Ill., July 2, 1877. Enlisted in Third Regiment Illinois Volunteers, April, 1898, and served during the war with Spain. Returned to coll. in 1899, but only remained a short time. Business. Clerk of City of Carpentersville, 1902-4. Grandmaster Dundee Lodge, A. F. & A. M., 1903-4. Mar-

ried Miss Georgiana M. St. Clair, Sept. 20, 1901.
Has one child: Frederick St. Clair. Addr., Carpentersville, Ill. Clubs: not given.

*JOHN BAPTISTE ASHE, '30. Born 1810. A.B., 1830. Rep. to Cong. from Tennessee, 1843-1845. Died March, 1858.

*CHARLES ALEXANDER BACKUS, '52. Born 1832. Left coll. January, 1850, to go into business. Lawyer. Died at Yankton, Dak., Dec. 31, 1872.

FREDERICK STANLEY BACON, '99. Born Feb. 27, 1877, Middletown, Conn. Left coll., 1899. Entered Yale Law School, where he graduated in 1902. Practised law at Hartf. and Middletown, Conn. Sec. and Treas. of the Annual-Wind Clock Co., Middletown, Conn. Sec. and Gen. Man. of the Ammonine Mfg. Co.; Mason; Dir. Col. Club (Middletown, Conn.); Sec. Middletown Yacht Club. Addr., Middletown, Conn.

JOHN WATSON BACON, '46. Born at Hartf., Conn., June 9, 1827. *Φ. B. K.* Valedictorian. A.B., 1846; A.M., 1849. Studied law, afterwards took up civil engineering. Jun. Fellow, 1858-61. In 1877 was appointed one of the R. R. Comrs. of the State of Conn., held this office until 1887; afterwards appointed a Comr. of Conn. Topog. Survey. Pres. Danbury Sav. Bank; Danbury Mut. Fire Ins. Co.; Danbury Cem. Assoc.; and Dir. Danbury Nat. Bank. Married Miss Caroline E. Botsford at Danbury, Conn., Dec. 20, 1852. Has three children: Sarah W.; Eliza W.; John R. Addr., Danbury, Conn. Clubs: not given.

JOHN BAKEWELL, '59. Born Feb. 26, 1838, at Pittsburgh, Pa. *Φ. B. K.* Oration Commencement.

A.B., 1859; D.D. (Coll. of Sisters of Bethany), 1875. Studied at Va. Theol. Sem., and Phila. Div. Sch. Ordained: Deacon, 1864; Priest, 1865. Rector var. churches, among others: Grace (Topeka, Kan.) in 1871 and St. Paul's (Trenton, N. J.) 1877. Last charge, Trinity, Oakland, Cal., which parish he founded. Resigned in 1903, and appointed *Rector Emer.* During his rectorship the three churches of Trinity (Wichita, Kan.), Trinity (Santa Barbara, Cal.), and Trinity (Oakland, Cal.), were erected. Twice married: first to Miss Maria E. Vail, at Lawrence, Kan., Jan. 9, 1868. They had six children: Harriet B.; Annie S.; Thomas V.; Benjamin, and Walter B.; second: to Mrs. Harriet W. Turner (Winslow), at Santa Barbara, Cal., Aug. 4, 1887. Addr., 1219 Telegraph Ave., Oakland, Cal. Clubs: not given.

HENRY GRAY BARBOUR, '06. Born Mar. 28, 1886, at Hartf., Conn. Son of John H. Barbour, '73. Mackay-Smith Prize (Analytics), 1904. Track team, 1903-4. Student in coll. Addr., 217 Farmington Ave., Hartf., Conn.

*JOHN HUMPHREY BARBOUR, '73. Born May 29, 1854, at Torrington, Conn. Son of Judge Henry A. Barbour. *A. K. E.* at Amherst. Entered Freshman Class, May, 1870. *Φ. B. K.* Oration Commencement. A.B., 1873; A.M.; S.T.D., 1899; graduated from Ber. Div. Sch., 1876. Ordained Deacon, 1876; Priest, 1878. Instructor in Mathematics, 1878, and Instructor in Botany, 1887; Librarian of the coll., 1882-89; Jun. Fellow, 1884-93. Became Prof. of New Testament History at Ber. Div. Sch. in 1889. Librarian Ber. Div. Sch., 1889, to time of his death. Secr. Al. Assoc., 1892-96. Contributed to periodicals,

his most valuable writing being an investigation of the composition of the Apocalypse, and the latest shortly before his death an article on "The Study of the New Testament," published in *The Churchman*. Author of a Manual of Instruction for Confirmation, and compiler of "The Beginning of the Historic Episcopate." Married Miss Annie Gray, at Hartford, May 7, 1878. He had four children: Ellen; Mary W., died 1885; Henry Gray; Paul H. Died April 29, 1900.

ROBERT BARCLAY, '80. Born May 8, 1857. A.B., 1880; A.M.; M.D., 1883, Coll. Phys. and Sur. Practising medicine in St. Louis, Mo. Author of var. monographs relating to his profession. Addr., 3894 Washington Boulevard, St. Louis, Mo.

HENRY PAINE BARTLET, '72. Born April 19, 1850, at Newburyport, Mass. Left coll. April, 1869, to go into business. Lived in Calcutta, India, and in Brazil for some years. Married Mrs. Amelia S. Dickson, at Stamford, Conn., in 1897. At present in business as Banker and Broker, at 41 Wall St., N. Y. City. Clubs: Church; Calumet; Down Town Assoc.; N. Y. Yacht.

*WILLIAM HENRY BAYARD, '41. Born 1820, N. Y. City. Left coll. on account of ill health in 1840. Died at Mineola, Minn., Jan. 11, 1882.

*JAMES ROOSEVELT BAYLEY, '35. Born at Rye, N. Y., Aug. 23, 1814. Grandson of Dr. Richard Bayley, Prof. of Anat. Col. Coll. A.B., 1835; S.T.D., Rome, 1853. Ordained Deacon, 1839. Became a Roman Catholic, 1842. Ordained Priest (R. C.), 1844. Vice-Pres. St. John's Coll., Fordham, N. Y.
