It was announced early in 1872, that the Bishops of the Proyince of Canterbury would invite the Lower House of that Province to consider what method of dealing with the Athanasian Creed would tend to remove the difficulties which it was alleged were occasioned by its present use in the Service of the Church of England; a Committee of Clergy and Laity was therefore organized by the exertions of a few Laymen, and the following circular was issued to all the Parochial Clergy of England and Wales.

"REVEBEND SIR,

"WE, the undersigned, beg leave to urge upon you very seriously the importance and necessity of obtaining the signatures of your parishioners to a petition, headed by yourself, to the Lower House of the Convocation of Canterbury, or to the Convocation of York (according to your province), in favour of maintaining the Athanasian Creed in its integrity in the Public Service of the Church."
