\* Adapted by Mr. Arnold from a German manual of Etymology, printed or in type at the time of his decease. It should be observed that this Vocabulary does not aim at scientific exactness, and, where the etymology of a word is not obvious, sometimes gives it either as a separate article, or places it under the word which it most nearly resembles. Thus, *li-bra*, 674, is a derivative of *lia*, *tol*, 1296 (see *W.-B.* 183); *li-bra*, 420, and *li-dra*, 422, belong to the root of 427: again, *labor*, *bris*, placed under 624 (*labi*), belongs to *lia*, *tol* (see *W.-B.* 176 and *Questions*, p. 216, note 3).
