

GENERAL TREASURER'S OFFICE. PROVIDENCE, R. I., January 1, 1912.

To the Honorable the General Assembly of the State of Rhode Island and Providence Plantations:

In accordance with provisions of Section 19, Chapter 43 of the General Laws of Rhode Island, 1909, a detailed statement is submitted herewith of the receipts and disbursements of the treasury department for the year, ending December 31, 1911.

While the available cash in hand at the close of business for 1911 is not large, all demands made upon the treasury during the year have been promptly met and the outstanding floating debt of the State has been paid.

Additional revenue from the State tax, based upon existing laws may be expected for 1912, as the returns of the Boards of Assessors of the several towns and cities show an increase in valuation of real and personal estate: real, \$12,298,600; personal, \$3,941,074; a total of \$16,239,674 over 1910.

Reference to the table below shows conclusively that unless the bills before the legislature providing additional revenue are made operative, appropriations for considerable sums, either for special objects or permanent improvements must await the future for payment.
