EXTRACT

FROM

THE REGISTRY OF TRINITY COLLEGE, DUBLIN.

" Feb. 22, 1794. Whereas a legacy of £1248 has been bequeathed to the College of Dublin, by Mrs. Anne Donnellan, of the parish of St. George, Hanover-square, in the County of Middlesex, spinster, for the encouragement of religion, learning, and good manners, the particular mode of application being intrusted to the Provost and Senior Fellows:—

" RESOLVED,

" 1. That a Divinity Lecture, to which shall be annexed a salary arising from the interest of £1200, shall be established for ever, to be called Donnellan's Lecture.

" 2. That the Lecturer shall be forthwith elected from among the Fellows of the said College, and hereafter annually on the 20th of November.

" 3. That the subject or subjects of the Lectures shall be determined at the time of election by the Board, to be treated of in six sermons, which shall be delivered in the College Chapel after Morning Service on certain Sundays, to be appointed on the 20th of November next after the election of the Lecturer, and within a year from said appointment.

“4. That one moiety of the interest of the said £1200 shall be paid to the Lecturer as soon as he shall have delivered the whole number of Lectures, and the other moiety as soon as he shall have published four of the said Lectures; one copy to be deposited in the Library of the College; one in the Library of Armagh; one in the Library of St. Sepulchre; one to be given to the Chancellor of the University; and one to the Provost of the College.”

LECTURE I.

THE FIRST PROMISE.

GENESIS, iii. 15.

And I will put enmity between thee and the woman, and between thy seed and her seed. It shall bruise thy head, and thou shalt bruise his heel.

Presumptive order of the Prophetic Revelations—not the actual order—and wherefore? pp. 1-3. Burden and Theme of Prophecy, p. 4. To illustrate this in the earliest prophecies on record is the object of this Course of Lectures, p. 5.

The First Promise evidently not fulfilled as yet, p. 6.

I. Its scope and ultimate reference inferred:—1. From its being a sentence of judgment on the Serpent, pp. 7-9. 2. From the character of the promised Redeemer's coming, p. 10.

II. The Fulfilment:—1. Partial at the First Advent—as regards the Person of the Redeemer, p. 11; and the "enmity," pp. 12-14. Still in course of fulfilment, p. 15. Corresponding character of the present Dispensation, p. 16. 2. When to be completely fulfilled?—To be inferred from its scope before noticed, p. 17. This inference confirmed by a parallel prophecy—that of the *Dragon or Serpent-power* in the Apocalypse, pp. 18-20. Final catastrophe at the Second Advent, pp. 21, 22. Relation of this first to subsequent prophecies (Davison), p. 23. Its bearing on the present hope of the Church (*ib.*), p. 24.

LECTURE II.

THE PROPHECY OF ENOCH.

ST. JUDE, ver. 14, 15.

And Enoch also, the seventh from Adam, prophesied of these, saying, Behold, the Lord cometh with ten thousands of His saints, to execute judgment upon all, and to convince all that are ungodly among them of all their ungodly deeds which they have ungodly committed, and of all their hard speeches which ungodly sinners have spoken against Him.

Recapitulation:—The scope and theme of the Prophecies of the Redemption in general, as stated in former Lecture, and exemplified in the first, p. 27. This Prophecy a remarkable confirmation of it, p. 28. Found in the apocryphal "Book of Enoch," but not therefore quoted from it, *ibid.* Connexion with the notice of this Patriarch in Gen. v., and inference as to—

I. The circumstances under which the Prophecy was uttered, p. 29.

1. General import of the words "walked with God," as distinctive of God's servants at all times, p. 30.

2. Special additional inference from this, his character, in Enoch's instance, as connected with his translation, and the comment of Heb. xi. 5,—p. 31. This confirmed by his Prophecy, pp. 32, 33.

II. The Fulfilment.

1. A prophecy of the Redeemer's second coming, p. 34. Had a proximate reference to the Deluge, pp. 35, 36. Not, however, then fulfilled, as proved by its context in St. Jude, which determines it to "the last days" of this Dispensation, pp. 37–39.

2. As a prophecy of judgment, it confirms the character of the Redeemer's coming previously foretold in the First Promise, together with the issue of this Dispensation, p. 40. Its importance in this view to the Church of the present day as warning, pp. 41, 42. And also as confirming the hope of those found faithful in "the last days," pp. 43, 44. Enoch's translation a type, pp. 45, 46.

LECTURE III.

THE EXPECTATION OF JOB.

JOB, xix. 25-27.

For I know that my Redeemer liveth, and that He shall stand at the latter day upon the earth: And (though) after my skin (worms) destroy this (body), yet in my flesh shall I see God: Whom I shall see for myself, and mine eyes shall behold, and not another; (though) my reins be consumed within me.

Date of the history of Job. Proofs that he lived before the Exodus, p. 50. The same reasoning would infer a still earlier date, *ib.* Dr. Hales's computation, p. 53.

I. The distinctive character of Job's TRIAL.

An exemplification of the "enmity" of the Serpent foretold in the first Promise, pp. 54, 55. The account of Satan's agency in it not allegorical, nor peculiar to the Old Testament writers, p. 56. Another aspect of his trial as permitted by the Lord, pp. 57, 58. The former confirmed by the import of his name, p. 59.

II. The "REDEEMER" of Job's expectation identical with the Redeemer of the two preceding prophecies, p. 60. Proved—

1. By the context, the occasion on which it was uttered, and his own testimony as to the nature of his trial, pp. 61-63.

2. By the import of the original term for "Redeemer" here, illustrated by a typical ordinance of the Jewish law, p. 64. A twofold Redemption shadowed forth under the Old Testament, p. 65. The objects respectively of the two Advents of the Saviour, p. 66. The Resurrection an exercise of redemption in the latter definition, and by the Redeemer under the title by which He is here foretold, pp. 67-69. Additional confirmation of the character of Job's trial and of the scope of his prophecy by a reference to it in the Epistle of St. James, p. 70. The end of Job's history an earnest of his expectation, p. 71. Concluding application, p. 72.
