

It is, however, a compilation of those foreign journals which the various divisions of the Bureau of Foreign and Domestic Commerce have found of distinct value in keeping in touch with foreign conditions in the geographical regions indicated. Doubtless many omissions will be noted and the journals here listed will be found of unequal value. A few American journals have been included, especially those which deal primarily with foreign countries. A brief statement of the field covered by each journal is included.

Subscriptions to these journals usually can be entered through American subscription agencies that specialize in foreign magazines, or by direct address to the periodical concerned.

WESTERN AND CENTRAL EUROPE.

UNITED KINGDOM.

GENERAL JOURNALS.

Anglo-American Trade and Chamber of Commerce. London. Monthly and annual. Published by the American Chamber of Commerce in London. Contains articles on reciprocal trade opportunities in England and America, advertising, ports, etc.

Barelay's Bank Reports. London. Monthly.

Financial statement of leading banks of England, giving exchange rates, bank holdings, etc.

Board of Trade Journal, The. London. Weekly.

Summaries of colonial reports and digests of trade returns and tariff measures. Schedules of fairs are given and general commercial information.

British Export Gazette, London. Monthly.

A sales export journal. Contains information on commerce and industry; business inquiries; items of interest to buyers; West African market reports; markets and prices.

British Trade Review. London. Monthly.

Incorporated with The Foreign and Colonial Importer. An independent organ of British overseas trade of interest to merchants, importers, manufacturers, engineers, builders, contractors, and raliway companies.

Chamber of Commerce Journal, The. London. Monthly.

A survey of such current topics as fairs, industrial conditions, overseas trade reports, special articles on the trade of various sections of the Empire, finance, commercial cases in the courts, and reports of London Chamber of Commerce.

Compendium. London. Monthly.

A monthly digest of market movements and prices current in the coal, metal, and shipping trades of the world.

Economic Journal, The. London. Quarterly.

Quarterly journal of Royal Economic Society. Contains artices on such economic topics as wages, taxation, money, etc.; a valuable section of book reviews, notes and current topics, and lists of recent periodicals and new books.

Economic Review, The. London. Weekly.

A compilation consisting of digests and translations of leading articles in economic and financial journals of the world; also notes on tariff measures.

Economist, The. London. Weekly.

General economic journal dealing with international commercial affairs. Often important financial and budget summaries appear and also production tables.

Federation of British Industries, The Bulletin of the. London. Monthly.

Articles on home affairs of interest to manufacturers and on overseas trade and industrial raw materials.

Financial Review of Reviews, The. London. Quarterly.

"The policy of the Review has been to keep its readers informed on matters generally affecting the question of investment, and, in cooperation with its proprietors, the Investment Registry (Ltd.), to assist investors in the general management of their securities."

Geographical Journal, The. London. Monthly.

Journal of Royal Geographical Society. Contains geographical descriptions of countries and other geographic topics, many of which are of commercial interest; also valuable bibliographic material on geographic regions.

Imperial Institute, Bulletin of the. London. Quarterly.

"A quarterly record of progress in tropical agriculture and industries and the commercial utilization of the natural resources of the Dominions, Colonies, and India."

Interim Reports (White Papers). London. Intermittent.

Official reprints of parliamentary proceedings.

Labour Gazette, The. London. Monthly.

Reports on employment-mining, shipbuilding, textiles, leather, construction, paper, agriculture and food preparation, trades, etc.; exchanges from Ministry of Labour; unemployment in insured industries; employment overseas; trade disputes; principal changes in rates of wages reported during preceding month; legal cases affecting labor.

Observer, The. London. Weekly.

General survey of British business conditions; also contains political and social matters.

Production and Export, The Journal of the British Empire Producers' Association. London. Monthly.

A journal dealing solely with production in the British Empire, with pictures and tables of figures giving quantity or value of production; import and export notes; foreign, industrial, and trade notes. Appended is a list of book or trade reviews and publications received.

Royal Society of Arts, The Journal of the. London. Weekly.

Reports and reprints of papers delivered before the society, usually on scientific subjects of general interest; very useful information on specific commodities in foreign fields.

Royal Statistical Society, The Journal of the. London. Four numbers a year. Contains reprints of papers delivered before the society, discussions on those papers, and an index of papers and documents filed in the society.

Spectator, The. London. Weekly.

Review of politics, economics, and trade, with critical comments upon the world situation.

Statist, The. London. Weekly.

General economic survey, with special emphasis upon such trade features as rubber production, mineral output, and market quotations.

Glasgow Herald, The. Glasgow. Daily.

Contains valuable articles on commodities-foodstuffs, automotives, etc.-and commercial news, money and exchange, stock market, and taxation.

Manchester Guardian Commercial. Manchester. Weekly.

General economic, financial, and commercial journal, especially valuable to the textile, iron and steel, and foodstuffs industries. Special editions of this journal review the various industries of Great Britain in detail.

The Times Trade Supplement. London. Weekly.

General economic, financial, and commercial survey of the world and world markets. Special editions are issued occasionally covering particular industries. The annual trade review is especially complete for British industries.

TRADE JOURNALS.

AUTOMOTIVE.

The Autocar. London. Weekly.

Illustrates the designs of cars and inventions; queries regarding motor mechanism and replies.

The Automobile Engineer. London. Monthly.

Official organ of the Institute of Auto Engineers. Contains technical articles on the automotive industry, institute notices, correspondence, etc.

Commercial Motor. London. Weekly.

An authoritative source of information on all forms of motor transportation. Contains illustrations of various types of motors and machines.

The Motor. London. Weekly.

The National Motor Journal. Contains special articles on the motor industry by experts, editorials, accessories, innovations, and equipment.

The Motor Boat. London. Weekly.

Contains information for all interested in large and small pleasure motor craft and commercial motor vessels for coastwise service and inland waterways.

Motor Transport. London. Weekly.

Contains the latest information in transportation matters; shows special features for drivers and mechanics; gives transport news and comments, and costs of running and maintenance; illustrates descriptions of new vehicles, motor haulage developments, and includes road transport politics, practical notes for drivers, and legal notes.

CHEMISTRY.

Chemical Age. London. Weekly.

Devoted to industrial and engineering chemistry.

Chemist and Druggist. London. Weekly.

Devoted to pharmacy and the drug trade. Gives important news about the drug and chemical trades, including market reports and trade articles.

Journal of the Chemical Society. London. Monthly.

Contains reports of the transactions of the Chemical Society of London.

ELECTRICAL TRADE.

Beams. London. Monthly.

A monthly journal of electrical and allied engineering. It contains a classified directory of manufactures in French, Spanish, Italian, and Portuguese and an index to electrical companies.

Electrical Review. London. Weekly.

Contains reviews on the electrical industry, new patents, published specifications, share list of electrical companies, market quotations, and official returns of the leading electrical companies of Great Britain.
