PREFACE.

The earliest Register of the Parish of Boughton-under-Blean is a parchment volume, measuring 18½ inches by 6½ inches and containing one hundred pages, fifty folios, of which forty-seven are covered with entries. The purchase of this book is recorded in the Churchwardens' Accounts for 1598 in the following terms: "Ite. for a Register book of parchment xiis," and the accuracy of the transcripts of the entries up to that date is testified by the signatures of Wm. Place (Vicar of Boughton 17th March, 1589, to his death in 1637—buried April 7th) and Richard Rucke, one of the Churchwardens, and the mark of Thomas Hendman the other Churchwarden.

The Baptisms are recorded from 3rd April, 1558, to 20th June, 1624, with a hiatus from 9th January, 157% to 23rd November, 1571; the Marriages from 14th June, 1558, to 15th May, 1626, with a hiatus from 28th December, 1570, to 9th June, 1572; and the Burials from 1st April, 1558, to 15th March, 162%, with a hiatus from 8th January, 157%, to 19th November, 1571.

The writing is for the most part legible, so that there are very few words which it has not been possible to decipher.

RECTORS AND VICARS.

The principal Manor and Church of Boughton under the Blean ("Bocton subtus le Bleyn" as it is styled in the old Church Book dating from 1534) are among the most ancient possessions of the See of Canterbury, the Archbishop being mentioned in Doomsday Book as holding the lands himself.

Before the year 1340 the Archbishop appointed the Rector of Boughton, and the Rector appointed a Vicar, as well as a Chaplain to the dependant Chapelry of Hernhill. But on 3 April 1340 the Rectorial Tithes and the Rectory House were exchanged by Archbishop Stratford with the Abbey of Faversham for other lands. At the Dissolution of Religious Houses in 1538 these Tithes, with the other revenues of Faversham Abbey, were seized by King Henry VIII, who by his dotation charter in 1541 settled them upon his newly-appointed Dean and Chapter Canterbury. In recent times these Tithes passed to the Ecclesiastical Commissioners, but have been re-transferred by them to the Dean and Chapter. As a part of Archbishop Stratford's transaction with Faversham Abbey, he retained for the Archiepiscopal See the patronage of the Vicarage of Boughton as well as the patronage of Hernhill, which was then constituted a Vicarage.
