### General Assembly of the State of Vermont

JOINT RESOLUTION.

Resolved by the Senate and House of Representatives:

That the Clerk of the House of Representatives be directed to procure the printing of twelve hundred and fifty copies of the Proceedings of the Annual Meetings of the Vermont Historical Society held October 15th, 1901, and October 14th, 1902, and of the Adjourned Annual Meeting of said Society held October 30th, 1902, including the Address of its President, and the papers of Dr. David S. Kellogg of Plattsburg, N. Y., on "Early Mention of Events and Places in Lake Champlain Valley," and Hon. Robert D. Benedict of New York City, on "Ethan Allen's Use of Language," read before said Society, to be disposed of as follows: To each member of the Senate and House of Representatives, one copy; to each Town and City Clerk, one copy; to each College, Normal School, Academy, High School, and Public Library, one copy; to the Governor, each of the Heads of Departments, and each Judge of the Supreme Court, one copy; to the Vermont Historical Society four hundred copies, and the remainder to the State Library subject to the control of the trustees thereof.

The Auditor of Accounts is hereby directed to draw an order on the State Treasurer in favor of the Clerk of the House of Representatives for such sum of money as may be necessary to pay the expense of printing and distributing the same.
