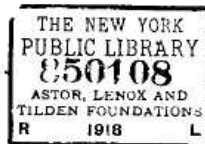

## PREFACE.

THIS volume contains a verbatim report of an event which, without exaggeration, has been fittingly characterized as the "most momentous in the history of life insurance," and as such, is of vital interest and value to every individual worker in this vast and fertile field of labor.

The unification of the great moving force of life insurance has been successfully achieved, and the reader may well pause and consider what this suggests; for, as Dr. Fowler so ably set forth, the mere fact of organization is but a prelude to further development, a development rich with the brightest possibilities for the advancement of a profession and institution that have already laid a foundation of surpassing strength for future achievement to rest upon.
